Reference: Results of B6 Constraint Management Pathfinder (2023/24)

Dear Industry Colleagues,

National Grid Electricity System Operator (NGESO) published its Invitation to Tender (ITT) for the B6 Constraint Management Pathfinder (CMP) (2023/24) on Monday 23/08/2021 with the aim of connecting successful parties to an intertrip scheme above the B6 (SCOTEX) boundary for expected service delivery from October 2023 through to September 2024. This letter seeks to update all interested stakeholders on the outcome of the B6 CMP (2023/24).

## Pathfinder Outcome:

NGESO would like to thank those who took the time to express an interest in and participate in the B6 CMP (2023/24) tender process. The results of the tender process can be found in the Results Table published on the next page of this letter. Please note that all assets that participated in the B6 CMP (2023/24) tender process have been awarded contracts, from in excess of 50 assets that originally expressed an interest in the service. These successful parties shall help to reduce network constraint costs across the B6 (SCOTEX) boundary from October 2023 (or earlier wherever possible) through to September 2024 – the anticipated savings during the service term are in the region of £20m-£40m dependent upon the generation background driving the constraint and system conditions.
