• JESG Actions Review

The Technical Secretary noted the JESG Standing Actions and updates on current actions. The current
version of the JESG action log, including any additions from this meeting, is <u>attached to this Headline</u>
<u>Report</u>.

• The GB Implementation Plan, Jemma Williams, Elexon

- Jemma Williams attended the JESG to update the Group on the Forward Workplan that has been developed by the Code Administrators and co-ordinated by Elexon. She explained that the European area of work on the plan was just one aspect of all of the work that is captured on the plan.
- She stated that the Plan is updated and discussed on a monthly basis by Code Administrators.
- The Plan is due to be reviewed and verified by all GB Code Panels and comments fed back to Elexon. She stated that this was already due but due to the movement of the Grid Code Review Panel this action is due to be completed by the end of May 2017.
- She explained to the Group that the purpose of the document is to improve transparency of all of the anticipated changes but emphasised that it was important especially where there are due to be cross code impacts that all Code Panels are aware of the impacts.
- Discussions were had around evolving the current Forward Workplan into a document that could be used as a Compliance document once and during all Modifications being implemented into GB.
- It was noted that JESG stakeholders requested that there would like a monthly update on the Forward Workplan. An action was taken to speak to the Code Administrators, at their next monthly meeting to arrange how an update will be given to the JESG each month. This meeting is due to be held on the 30th May 2017.
- A further request was made that the Forward Workplan link would be included in the JESG Weekly update on a monthly basis, where appropriate.
- Lastly it was also noted and discussed that the main concern from both a Stakeholder and Code Administrator Group is that of timings and ensuring that everything is raised and developed in a timely manner.
- (CACM) TSO Proposals on gate timings, fallback and day-ahead firmness deadline Thomas Jones Ofgem
- Thomas attended the meeting and talked through his slides. He asked the Group whether they had any concerns around slide 12. One Stakeholder noted that they would expect there to be more trade completed within the UK rather than waiting and taking more 'risk' in the EU markets. The timings that are currently in place were noted that these were the current benchmark.
- Another Stakeholder questioned whether, if an order was lodged just ahead of the gate closure whether there would be risk that this could not be fulfilled due to the process. It was noted that this could be true.
- Ofgem noted that they would come back to another JESG meeting to present on the submissions outlined within the slide pack.

- It was noted that it would be beneficial for the Group to discuss any information they have with regards to Entry into Force dates as and when they get or hear information to ensure everyone is as up to date as possible. This was not taken forward as a Standing agenda item but was noted by all to ensure, should they have an update that they would give it to the Group where appropriate.
