#### 1 Why Change

- 1.1 The Proposer has raised a housekeeping Modification to amend Section 14 of the CUSC due to the Authority directing CMP264, CMP265, CMP268 and CMP282 to be implemented on the 1 April 2018.
- 1.2 In order to effectively implement the Modifications the Proposer believes that a housekeeping change is required since implementing the legal text as they stand for each Modification will not make sense; a number of errors have been identified and become apparent as a result of the time passed and the development other Modifications since the earlier decisions.
- 1.3 The Proposer believes that CMP290 meets the Fast Track Criteria since the Modification proposes to amend Section 14 by the following:
  - Correct minor typographical errors
  - Correct formatting and consistency errors
  - Update paragraph numbering
  - Update/remove incorrect references
- 1.4 CMP264 and CMP265 requires amendments to the legal text to correct formatting and consistency errors in particular adding in '-'to be consistent in relation to export within the examples in Section 14.28; to update the paragraph numbering and the removal of incorrect uses of 'affected'.
- 1.5 CMP268 requires amendments to the legal text to correct formatting and consistency errors in particular the insertion of 'Conventional Low Carbon' in clause 14.18.7 as well as a spelling error within clause 14.8.3. and a close bracket inserted in formulae in clause 14.18.7.
- 1.6 CMP282 required amendments to the legal text to correct formatting and consistency errors and updates to paragraph references.
- 1.7 For ease the Proposer has implemented the legal text for all Modifications to Section 14 with track changes and annotations explaining the changes being made by this Modification. This forms the proposed legal text for this housekeeping Modification and has been summarised in the table below.

#### 2 Solution

- 2.1 It is proposed that a number of changes are made to CUSC Section 14. The proposed updates can be found in the change marked text in Attachment 1 and Attachment 2 of this document.
- 2.2 This modification ensures that when these modifications are implemented on 1 April 2018 that there are no typographical errors, the formatting is correct and consistent, the paragraph numbering is aligned and the are no incorrect references throughout.
- 2.3 This modification will not impact CMP269 and CMP270 that were the consequential changes raised for CMP264 & CMP265 as these changes impact Section 11.

## 3 Proposed Legal Text Implementation

Please refer to Attachment 1 for the track marked proposed changes to Section 14 and Attachment 2 for the clean version of Section 14.

#### 4 CUSC Panel Determination

4.1 On 23 February 2018 the CUSC Modifications Panel considered whether CMP290 met the fast track criteria and whether the CUSC Modification should be made.

The Panel unanimously decided that this Modification met the Fast Track Criteria as detailed below:

#### Fast Track criteria

is properly a housekeeping modification required as a result of some error or factual change; including but not limited to:

- i) updating names or addresses listed in the CUSC;
- ii) correcting minor typographical errors;
- iii) correcting formatting and consistency errors, such as paragraph numbering or
- iv) updating out of date references to other documents or paragraphs.

The Panel requested further detail of the changes being proposed and upon review the Panel decided that this Modification would be implemented on 1<sup>st</sup> April 2018.

#### 5 Implementation

5.1 CMP290 CUSC Modification Fast Track Proposal will be implemented on the 1<sup>st</sup> April 2018 following the publication of the approved CUSC Modification Fast Track Report and subject to no appeals being raised as per the objection process described in Section 6.

This is due to the modifications CMP264, CMP265, CMP268 and CMP282 being implemented on this date and for the referencing and numbering to be correct at the time of publication.

#### 6 Objections

- 6.1 CMP290 has been approved by the CUSC Modifications Panel; if you have an objection to the Modification, you have an opportunity to raise this, no later than 17:00 on 19 March 2018.
- 6.2 The Approved CUSC Modification Fast Track Proposal will not be implemented if an objection is received.
- 6.3 The CUSC Panel Secretary will notify the CUSC Panel, the Authority and CUSC Parties if an objection is received.
- 6.4 The CUSC Panel Secretary shall notify the proposer that additional information is required if the proposer wishes the CUSC Fast Track Modification to continue as a CUSC Modification Proposal.
