Panel Determination vote

Background

EU legislation requires NGET to contribute data towards a pan-EU Common Grid Model.

- Regulation 2015/1222 – Capacity Allocation and Congestion Management (CACM) which entered into force 14 August 2015
- Regulation 2016/1719 – Forward Capacity Allocation (FCA) which entered into force 17 October 2016

The legal right for NGET to share the data with EU TSOs arises from the CACM guideline; however several stakeholders have requested a Grid Code Modification be raised so that it is transparent to all parties which data will be shared

Governance background

- Raised originally at May 2017 Panel
- Resubmitted to Grid Code Panel in July 2017
- Initial Code Administrator Consultation ran from 21 August until 12 September 2017
- Authority quashed Panel Determination Vote and modification returned to the Grid Code Review Panel
- Proposer re-drafted legal text and the Panel issued to second CA consultation
- Closed on 8 June – 2 responses

Governance Rules

GR.24.9 Subject to GR.24.11, if the Authority does not give written notice that its decision is required pursuant to GR.24.2, or if the Authority determines that the Self-Governance Criteria are satisfied in accordance with GR.24.4, then the Grid Code Modification Self-Governance Report shall be tabled at the Panel Meeting following submission of that Grid Code Modification Self-Governance Report to the Authority at which the Panel Chairman will undertake the Grid Code Review Panel Self-Governance Vote and the Code Administrator shall give notice of the outcome of such vote to the Authority as soon as possible thereafter.

GR.24.10 If the Grid Code Review Panel vote to approve the Grid Code Modification Proposal pursuant to GR.24.9 (which shall then be an “Approved Grid Code Self-Governance Proposal”) until implemented).

Panel Determination Vote

Does **GC0098** better facilitate the following Grid Code Objectives as below?

i)	To permit the development, maintenance and operation of an efficient, coordinated and economical system for the transmission of electricity
ii)	To facilitate competition in the generation and supply of electricity (and without limiting the foregoing, to facilitate the national electricity transmission system being made available to persons authorised to supply or generate electricity on terms which neither prevent nor restrict competition in the supply or generation of electricity)
iii)	Subject to sub-paragraphs (i) and (ii), to promote the security and efficiency of the electricity generation, transmission and distribution systems in the national electricity transmission system operator area taken as a whole
iv)	To efficiently discharge the obligations imposed upon the licensee by this license and to comply with the Electricity Regulation and any relevant legally binding decisions of the European Commission and/or the Agency; and
v)	To promote efficiency in the implementation and administration of the Grid Code arrangements

Grid Code Panel – 28 June 2018

Background

- The E&R required that a system operator produce a system defence plan, to be enacted in the event of significant issues affecting the system. It also required a restoration plan detailing the actions to be taken to restore supply in event that the system enters a Blackout state as defined by SOGL. Finally, it also details how the defence and restoration capabilities should be tested for compliance.

Code Administrator Consultation

- Closed on **17 May 2018**
- **Four** responses received
- Respondents stated improvements to legal text could be made
- Proposer relooked at legal text and circulated to Panel members for their consideration

Next steps and options

- Panel **Self-Governance Vote** or
- Second Code Administrator Consultation with revised legal text
