## 1 Introductions and Apologies for Absence

4539. Apologies were received from Rob Wilson, Neil Sandison, David Lyon and Deborah MacPherson.

4543. **Five Year Plan Quarterly Review**

The STC Panel had no further items to add to the STC Five Year Plan. This will be discussed next at the October 2018 Panel meeting.

4544. **STCP11-4**

MD advised the Panel that the trial for STCP11-4 has now ended. MD noted the Network Access Policy Workgroup are due to meet in June when a decision will be made on whether this STCP will be raised along with a full report detailing the findings.

MD noted he will circulate a draft briefing note to the Panel and at the July STC Panel he will be able to provide the Panel with a more complete update. The Panel Secretary is to ensure STCP11-4 is on the agenda for July's Panel meeting.

## 5 New STC / STCP Modification Proposals

4545. STCP13-2 SIF and LARF Methodology

LW advised the Panel that STCP13-2 was approved at the March 2018 meeting. Since the approval, it has become apparent that STCP13-2 has references to NGENSO. As NGENSO will not become a legal entity until 1 April 2019 we are unable to implement this STCP with those references. LW advised the Panel that the legal text has been amended to remove NGENSO from the STCP and replace with NGET.

The Panel approved the change to the legal text and STCP13-2 can be formally signed off. LW advised the Panel that the National Grid Legal Separation team will be raising a Modification in the future to amend NGET references to NGENSO. There is no known or immediate timescale for this modification.

## 6 Evaluation Phase/Workgroup Updates

4546. CM063 'Modify the definition of Force Majeure'

ND updated the Panel that this Modification was previously approved by Panel in March and a Workgroup is to be formed to assess and develop the proposal. ND noted that a Workgroup Terms of Reference and timetable have not yet been agreed by Panel to accompany this modification. ND invited the Panel to consider the scope of the Workgroup to focus their workings.

ND advised the Panel that the Workgroup nominations window is open until 12 June so the first Workgroup would not be convening until after that time ML requested Workgroup membership

ND noted the Code Administrator is responsible for facilitating the Workgroup meetings and therefore it would be useful to have the Panel's view on how many Workgroup meetings can be expected for this modification. Panel agreed that this Workgroup should conclude its work within 1-2 Workgroups. ML raised the question around the cross-code impacts of this Modification and if it is indeed possible to amend one code in isolation to the other codes. RF noted the potential CUSC impact and suggested the need for cross code working. ND agreed this should form part of the scope.

RW suggested that if Workgroup composition for CM063 does not differ from Panel members it would seem an efficient use of time to hold the Workgroup meeting immediately after the Panel. ND noted this as a valid suggestion adding that the Code Administrator will confirm the meeting arrangements once the nominations window has closed.

LW is to circulate the draft terms of reference to the Panel for comments for final approval at the June STC Panel.

4549. CM064 'Update to the STC Schedule 4, Boundaries of Influence'

LW delivered a presentation to the STC Panel which summarised the timeline and next steps for progressing CM064. The STC Panel unanimously agreed that the change satisfies the Self-Governance Criteria and would better facilitate the STC Applicable Objectives (a, b, d and f). The STC Panel unanimously determined that the Final Modification Report (FMR) would be issued to Industry for an Appeals Window of 15 Working Days and that, pending no Appeals being received, CM064 is to be implemented on 11 July 2018.

## 15 Europe

### 4555. **Joint European Stakeholder Forum (JESG)**

LW advised Panel that the most recent JESG was held on 8 May 2018 via WebEx. LW advised National Grid had provided updates on the SOGL, Emergency and Restoration (E&R) System defence and restoration plan and European Balancing Guidelines (EBGL) Article 18 & Article 49.. National Grid also updated on TSO/DSO developments. Ofgem also updated the JESG with on the current status of the Key Organisational Roles and Responsibilities (KORRR).

### 4556. **European Network Codes Impacts**

SS advised the Panel that Grid Code Modifications GC0100, GC0101 and GC0102 were approved by the Authority on 15 May 2018 and implemented into the Grid Code on 16 May 2018 as directed by the Authority. SS further advised Panel that the GC0097 Code Admin Consultation had been issued until 4 June 2018. The GC0104 Code Admin Consultation had also been issued until 8 June 2018.

SS noted a Special Grid Code Panel will be held on 14 June to undertake a Recommendation Vote on GC0097 (TERRE) and GC0104 (DCC Implementation).

### 4557. **TSO Issues**

The STC Panel raised no TSO issues.
