- a) **GSR023 N-1-1 Criteria** – Industry Consultation will close on the 20th July 2018. The Panel requested a reminder be sent out to industry to try and increase the number of responses to this. The Panel agreed to convene a short meeting in August to consider the consultation responses and make a recommendation on the Modification Report.
