**GC0112:** National Grid Legal Separation Grid Code changes to incorporate NGESO. The Panel agreed that the Terms of Reference had been met and that the modification can proceed to being issued to Code Administrator Consultation. This will be issued ahead of 24 August 2018. The Panel will hold their Recommendation Vote at the September Panel meeting ahead of submission of the Final Modification Report to the Authority.

**GC0108:** Emergency and Restoration: Black Start Testing Requirement. The Panel reviewed the Draft Final Modification Report that had been submitted to them. In light of the responses received to the Code Administrator Consultation the Panel decided that they would re-consult on revised legal text under GR22.4. The Code Administrator Consultation will be issued ahead of 24 August 2018. The Panel will hold their Recommendation Vote at the September Panel meeting ahead of submission of the Final Modification Report to the Authority.

**GC0110** Limited Frequency Sensitive Mode – Over-frequency (LFSM-O). The Panel reviewed the Draft Self-Governance Report and carried out their Self-Governance Vote. The Panel unanimously agreed that the modification better facilitates the Grid Code objectives and should be implemented. The appeal window for this modification will open shortly ahead of implementation at the start of October 2018 if no appeals are received.

The Authority noted that they would be making a decision on GC0097

Project TERRE and GC0104 EU Connection Codes GB Implementation

– Demand Connection Code within the next two weeks.
