# 1.0 SUMMARY AND RECOMMENDATIONS

#### **Executive Summary**

- 1.1 CAP153, Revision to CUSC Exhibits D Connection Application form, was proposed by National Grid and submitted to the CUSC Amendments Panel on the 29<sup>th</sup> June 2007. CAP153 aims to improve and update the CUSC Exhibit D, to provide greater clarity for Users when completing the Application forms and ensures the processes for application is efficient for all parties.
- 1.2 It should be noted that although CAP152-155 are separate CUSC Amendment Proposal the CUSC Amendments Panel permitted the Working Group to produce one Working Group report for all of the Amendment Proposals.

#### National Grid Recommendation

1.3 National Grid, as the proposer of CAP153 is supportive of the Working Group Alternative, believing that it would better and BEST facilitate the achievement of the Applicable CUSC Objectives (a) and (b).

#### Amendment Panel Recommendation

1.4 The result of the Panel Recommendation Vote as to whether the following BETTER facilitated the Applicable CUSC Objectives was as follows:

#### 2.0 PURPOSE AND INTRODUCTION

- 2.1 This Amendment Report has been prepared and issued by National Grid under the rules and procedures specified in the Connection and Use of System Code (CUSC) as designated by the Secretary of State.
- 2.2 Further to the submission of Amendment Proposal CAP153(see Annex 2) and the subsequent wider industry consultation that was undertaken by National Grid, this document is addressed and furnished to the Gas and Electricity Markets Authority ("the Authority") in order to assist them in their decision whether to implement Amendment Proposal CAP153.
- 2.3 CAP153 was proposed by National Grid and submitted to the CUSC Amendments Panel for consideration at their meeting on 26<sup>th</sup> June 2007. CAP 152 Working Group Report was submitted to the CUSC panel meeting on 30<sup>th</sup> September 2007. Following evaluation by the Working Group, the Amendments Panel determined that CAP153 was appropriate to proceed to wider industry consultation by National Grid.
- 2.4 This document outlines the nature of the CUSC changes that are proposed. It incorporates National Grid's recommendations to the Authority concerning the Amendment. Copies of all representations received in response to the consultation have been also been included and a 'summary' of the representations received is also provided. Copies of each of the responses to the consultation are included as Annex 3 to this document.

2.6 This Amendment Report has been prepared in accordance with the terms of the CUSC. An electronic copy can be found on the National Grid website, at <u>www.nationalgrid.com/uk/Electricity/Codes/</u>.

# 3.0 PROPOSED AMENDMENT

- 3.1 CAP153 proposes amendments to CUSC Exhibit D. The proposal aims to improve and update the CUSC Exhibit D, to provide greater clarity for Users when completing the Application form and ensure the process for application is efficient for all parties.
- 3.2 CAP153 amends CUSC Exhibit D Use of System Application for Embedded Generation, Distributed Interconnector Owner and Small Power Station Trading Party. In summary CAP153 seeks to improve the guidance notes for Users, address minor typographical errors, alignment and formatting issues. More substantially CAP153 requests additional information regarding the connection, clarifies technical questions and requests additional project programme data relating to key project milestones.

# 4.0 WORKING GROUP ALTERNATIVE

4.1 The Working Group developed an alternative for CAP153. The Working Group agreed with the intent of CAP153 and the Working Group Alternative is based on the proposed amendments described in section 3 of this report. The Working Group Alternative for CAP153 provides additional clarity to the draft legal text in terms of guidance notes and the questions / information requests.

# 5.0 ASSESSMENT AGAINST APPLICABLE CUSC OBJECTIVES

# **Proposed Amendment**

- 5.1 CAP153 would better facilitate the CUSC Objective(s);
  - (a) the efficient discharge by the Licensee of the obligations imposed upon it by the act and the Transmission Licence; and
  - (b) facilitating effective competition in generation and supply of electricity and facilitating such competition in the sale, distribution and purchase of electricity.
- 5.2 CAP153 ensures that the application forms are clear which will assist Users and National Grid in the efficient completion and processing of such forms.
- 5.3 The Working Group believed that CAP153 Original proposal would better facilitate the CUSC Applicable Objectives however the proposed amendment failed to address all the defects and clarifications identified by the Working Group.

# **Working Group Alterative Amendment**

- 5.4 The Working Group believed that CAP153 Working Group Alternative would better and best facilitate the CUSC Objective(s);
  - (a) the efficient discharge by the Licensee of the obligations imposed upon it by the act and the Transmission Licence; and
  - (b) facilitating effective competition in generation and supply of electricity and facilitating such competition in the sale, distribution and purchase of electricity.
- 5.5 CAP153 ensures that the application forms are clear which will assist Users and National Grid in the efficient completion and processing of such forms.

# 6.0 PROPOSED IMPLEMENTATION

6.1 The Working Group and National Grid propose CAP153 should be implemented 10 business days after an Authority decision because there is no adverse impact on CUSC Parties. In accordance with 8.19(b) views were invited on this proposed implementation date and National Grid did not receive differing views.

# 7.0 IMPACT ON THE CUSC

- 7.1 CAP153 requires amendments to Exhibit D of the CUSC. The text to give effect to the original Amendment Proposal is attached as Part A of Annex 1 of this document.
- 7.2 CAP153 Working Group Alternative requires amendments to CUSC Exhibit D. The text to give affect to CAP153 Working Group Alternative is detailed in Annex 1 Part B of this document.





Centrica welcome the opportunity to comment on CUSC Modifications 152-155 regarding revisions to CUSC exhibits B, D, F and I.

Please note that this response is non-confidential and covers CUSC Modification numbers 152 to 155 inclusive.

Centrica are broadly supportive of the Alternative Amendment Proposal and believe that it better facilitates CUSC Objective (a) in terms of simplifying the exhibits and making them consistent with one another and the terminology used in the CUSC.

With regards to the additional requests for information in the proposed modifications, Centrica would like to note that it will not be feasible to provide accurate timeline data relating to the project milestones set-out in the exhibits, at the point of application. The current planning and consents procedures are lengthy and unpredictable and therefore, milestone data / estimates provided in the connection application forms should not be used as concrete timelines, but instead aspirational guidelines. Quarterly reports and bilateral discussions should be used to monitor progress against milestones, and to adjust milestones, however, consequences for slippage of these milestones should not be penal if it can be demonstrated that the connection date in the connection offer can still be honoured by both parties.

Further additions to the exhibits, relating to information requests regarding GBSQSS compliance and ownership boundaries appear to be sensible and Centrica support these proposed changes.

In summary, Centrica believe that the Alternative Amendment Proposal seeks to improve the efficiency of the CUSC exhibits in question but remain cautious about the treatment of data supplied in accordance with project milestones.
