**Amendment to the Connection and Use of System Code (“CUSC”) - Decision and notice in relation to Proposed Amendment CAP079 “Table of Contents Document and CUSC Section10 – Transitional Issues – Contents”.**

The Gas and Electricity Markets Authority (the “Authority”<sup>1</sup>) has considered the issues raised in the Amendment Report<sup>2</sup> in respect of Proposed Amendment CAP079 “CUSC Section10 – Transitional Issues – Contents”.

The National Grid Company plc (“NGC”) recommended to the Authority that Proposed Amendment CAP079 be approved and that if CAP079 were approved that the Implementation Date should be 10 Working Days following the Authority’s decision.

Having considered the Amendment Report and NGC’s recommendation and having regard to the Applicable CUSC Objectives<sup>3</sup> and Ofgem’s wider statutory duties,<sup>4</sup> the Authority has decided to direct a modification to the CUSC in line with Proposed Amendment CAP079.

A separate letter contains the direction to NGC to modify the CUSC in accordance with CAP079 as set out in the Amendment Report.

<sup>3</sup> The Applicable CUSC Objectives are contained in Standard Condition C10 of the licence to transmit electricity treated as granted to NGC under Section 6 of the Electricity Act 1989 (the “Transmission Licence”) and are:

- (a) the efficient discharge by the licensee of the obligations imposed upon it under the Act and by this licence; and
- (b) facilitating effective competition in the generation and supply of electricity, and (so far as consistent therewith) facilitating such competition in the sale, distribution and purchase of electricity.

This letter explains the background to Proposed Amendment CAP079, and sets out the Authority's reasons for its decision. This letter constitutes notice by the Authority under section 49A of the Electricity Act 1989 in relation to the direction.

## **Background**

Amendment Proposal CAP079 was raised by NGC and submitted for consideration at the CUSC Amendments Panel Meeting on 18 March 2005. At the meeting the Amendments Panel determined that the Amendment Proposal should proceed to wider industry consultation. A consultation paper was issued on 24 March 2005 with responses invited by 22 April 2005. The Amendment Report was submitted to the Authority on 4 May 2005.

## **The Proposed Amendment**

CAP066 deleted paragraphs in section 10 of the CUSC including 10.5, 10.6, 10.7, 10.9, 10.11, 10.12 and the associated Appendix in section 10 as they were redundant. CAP066 also renumbered sections 10.8 and 10.10. Whilst this was the case CAP066 did not amend section 10's contents page or the CUSC's table of contents.

CAP079 was raised with a view to deleting references to headings 10.7 – 10.12 and the section's former Appendix, from the contents page of section 10 and from the table of contents to the CUSC. It also sought to amend the headings relating to current sections 10.5 and 10.6 in the contents page of section 10 and in the table of contents document.

It was thought that, by amending the table of contents in this way, the Proposed Amendment would improve efficiency in the amendment procedures themselves and thus enable NGC to more efficiently discharge its obligations under the Transmission Licence.

## **Respondents' views**

NGC issued a consultation paper on 24 March 2005 inviting responses from CUSC Parties and interested parties.

NGC received two responses to the consultation relevant to Proposed Amendment CAP079, both of which expressed support for the Proposed Amendment. One respondent questioned whether it was appropriate to retain section 10.6 (Pre-CUSC Voting of Amendments Panel).

The respondents' views are summarised and contained in the Amendment Report in respect of Proposed Amendment CAP079.

## **Amendments Panel Members' views**

No formal responses were submitted by Amendments Panel Members to the consultation in respect of Proposed Amendment CAP079.

### **NGC's recommendation**

The National Grid Company plc ("NGC") recommended to the Authority that Proposed Amendment CAP079 be approved and that if CAP079 were approved that the Implementation Date should be 10 Working Days following the Authority's decision.

### **Ofgem's view**

Ofgem considers, having had regard to the Applicable CUSC Objectives and Ofgem's wider statutory duties, that the Proposed Amendment, as set out in the Amendment Report, would improve the clarity and transparency of the CUSC and therefore would better facilitate achievement of the Applicable CUSC Objective C10 (1)(a).

### **The Authority's Decision**

The Authority has therefore decided to direct that Proposed Amendment CAP079, as set out in the Amendment Report, should be made and implemented. An attached letter contains this direction.
