

Headline Report – 26 July 2019

Connection and Use of System Code (CUSC) Panel

The CUSC Panel Headline Report is produced after every CUSC Panel and aims to provide an overview of the key decisions made. Minutes for this meeting will be published separately.

Approval of Panel Minutes

The meeting minutes from the Special Panel on 17 May 2019 and Panel on 28 June 2019 were approved subject to the incorporation of amendments requested by Panel members. These will be shortly available on the National Grid ESO website.

Prioritisation Stack

The latest version of the Workgroup Prioritisation Stack is set out in the “Prioritisation Stack July 2019” spreadsheet. CMP320 was added to the stack. Panel placed this modification in the middle of the stack due to the “Material cost to island generators and the proposed application in April 2024”.

CMP280/281, CMP292 and CMP295 were all removed from the Prioritisation Stack as have all moved beyond Workgroup stage.

New Modifications

There were two new modifications discussed this month:

New Non- Urgent Modifications

- **CMP319 – Consequential changes to Section 11 of the CUSC as a result of CMP280 and/or CMP281**

Panel agreed for this to proceed for Authority decision and to proceed to Code Administrator Consultation. This will be issued w/c 29 July 2019.

- **CMP320 - Island MITS Radial Link Security Factor**

Panel agreed for this to proceed for Authority decision and to proceed to workgroup. Next step is for the request for workgroup nominations to be sent out by the Code Administrator.

Authority Decision

The Authority confirmed they approved CMP295 on 4 July 2019; this was implemented on 5 July 2019.

The Authority confirmed they had received the Final Modification report (FMR) for CMP314, which was sent to them on 12 July 2019.

In flight modifications (in prioritisation order)

CMP303 - Workgroup 29 August 2019 to address Ofgem feedback after which Draft Final Modification Report to be re-presented to Panel (September Special Panel to be set up) and FMR to be re-issued shortly thereafter;

CMP317 – First Workgroup held 27 June 2019, Second Workgroup 22 July 2019. Further Workgroup being scheduled for August. Report to Panel in January 2020;

CMP315 – First workgroup to convene (5 September 2019 current proposed date) and a timetable to be provided thereafter;

CMP311 - Timeline approved in April's panel. On track with next workgroup 31 July 2019; workgroup consultation to be issued early August 2019;

CMP306 - Workgroup Report to be presented for Panel Approval at August 2019 Panel;

CMP291 - Workgroup cancelled due to quoracy; this has occurred three times and therefore there has been a request for additional workgroup members issued to the industry. Workgroup Report was to be presented for Panel Approval at August 2019; this won't be possible so need to request extension at August Panel once established extension period required;

CMP308 - Workgroup developing WACMs and legal text. July Panel agreed for this to be delayed to October 2019 as next Workgroup meeting won't be until September 2019;

CMP316 - First workgroup held 20 June 2019. The timeline will be created at the next workgroup in September 2019;

CMP320 – New Modification. Panel agreed for this to proceed for Authority decision and to proceed to workgroup. Next step is for the request for workgroup nominations to be sent out by the Code Administrator

CMP287 - Workgroup postponed due to quoracy issue. An extension has been granted until October 2019 to account for timing to meet;

CMP286 - July Panel approved an extension until January 2020 for workgroup report to be presented to Panel;

CMP288/289 - Extension granted at May Panel until September 2019 for Workgroup report to be presented to Panel. Extension granted at July Panel to extend to October 2019. Workgroup consultation and alternatives being developed;

CMP304 - Placed 'on hold' until July at the Panel in April awaiting outcomes of the National Grid ESO Roadmap. As National Grid ESO are not producing a Roadmap, agreed at July Panel that work on this Modification will restart;

CMP298 - Extension approved until December 2019 at July Panel for Workgroup report to be presented to Panel as Workgroup Consultation not to be issued until w/c 28 October 2019.

CMP300 - 1 WACM being developed extension granted until July. Seeking meeting ASAP to hold a WACM vote and then workgroup vote. An additional month's extension granted by July Panel; workgroup report to be presented to Panel in August.

***CMP271, CMP274, CMP276 and CMP307** are all on hold pending the outcome of the Targeted Charging Review / Significant Code Review.

Panel Vote

CMP292 - The Panel Members unanimously recommended that the modification should be implemented. The Final Modification Report will be sent to the Authority on 16 September 2019.

Workgroup Reports

CMP280/281

The Panel agreed the Workgroup had met the Terms of Reference and CMP280/281 should proceed to Code Administrator Consultation. This will be issued w/c 29 July 2019

CMP295

The Panel agreed the Workgroup had met the Terms of Reference and CMP295 should proceed to Code Administrator Consultation. This will be issued w/c 29 July 2019.
