Update STCP04-6 to add IEC60870-5-101 Communication Protocol

This proposal seeks to add IEC60870-5-101 (IEC101) to the list of acceptable communication protocols, alongside GI74. The update will also include the technical requirements for IEC101.

3. <u>Description of Issue or Defect that Proposed Modification seeks to Address</u> (mandatory field)

National Grid has approved IEC101 for its own use and has received expressions of interest to use this protocol from wind farm developers. The purpose of this proposal is to update STCP04-6 to allow use of this protocol (subject to any existing rules on type registration of equipment). It is expected that IEC101 will be preferred for all new TO assets covered by this STCP.

This change will not be retrospective. However, TOs with existing GI74 communications equipment are not prevented from changing to IEC101 subject to meeting the technical requirements in STCP04-6.
