Key areas of discussion

The Workgroup discussed the following:

- The Code Administrator advised that National Grid TO had been granted Materially Effected Party status for CMP288, with National Grid ESO becoming proposer for CMP289.
- The modification was recapped as the workgroup had not met since June 2019. The workgroup were taken through the current progress.

- The workgroup discussed various topics which followed on from previous workgroups, building on the progress made. Discussed at length were proposals for the calculation of any financing costs for infrastructure works, incremental costs and opex, targeting of costs of delays and backfeeds, and TO reporting requirements.
- The proposer of a potential alternative for CMP288, Simec, further clarified their alternative proposal, which the workgroup found useful as this helps with production of legal text.
- Legal text for the original solution from the proposer of CMP288 was also presented. The proposer will be taking this away and working on this for the next meeting.
- It was noted that some workgroup members not in attendance had previously indicated that they would like to raise modifications. The proposers and the ESO will follow up on this.
