#### Key areas of discussion

The workgroup discussed the following:

- The Proposer presented their modification proposal presentation to the workgroup and explained that the key purpose of the modification was to remove duplication of data submission by large generators. This would be achieved by allowing parties to submit data through the Regulation on Wholesale Energy Markets Integrity and Transparency (REMIT) platform and thus prevent the need to additionally use the Transmission Outages Generator Availability (TOGA) system.
- The workgroup discussed the implications of potentially removing TOGA at a future date and the work that would be required to understand the impact of its removal as a data submission option. The workgroup agreed that the additional work was required to ensure that there would not be any unintended consequences of removing TOGA and using REMIT. In particular, in relation to parties that may wish to use REMIT for data submission but who are not currently subject to REMIT obligations, whether they would now need to comply with those obligations if they started to submit data through the REMIT platform.
- Having considered the feedback from the workgroup, the proposer agreed to separate out the more contentious aspects that required further work from the modification solution. Therefore, the solution would now only encompass the additional option of using REMIT for data submission as an alternative to TOGA.

- The workgroup agreed that in the event that TOGA was to be removed as an option for data submission, a further modification should be raised so that detailed consideration of the implications could be undertaken.
- The workgroup agreed that there would be benefit in seeking wider industry views on the amended solution and therefore agreed that the modification should proceed to a workgroup consultation.

## Next step

The workgroup agreed that the next meeting should take place on 6 November 2019 to finalise the workgroup consultation document prior to issuing it to industry.
