1. Introductions and Apologies for Absence

4866. Apologies were received from Nicola Bruce, Keith Jones and Neil Sandison.

2. Approval of Minutes from Previous Meeting

4867. The Panel approved the minutes from the meeting held on 25 September 2019. The Panel Secretary will arrange publication of the minutes.

3. Review of Actions

4868. The Panel reviewed the open actions from the meeting held on 25 September 2019 which can be found on the Actions Log.

4. STC/STCP Modification Proposals

4869. There were two draft STCP Modification proposals presented to the Panel.

PM0113 'Update STCP14-1 'Data Exchange of charge setting' to reflect CUSC Modification CMP306 'Align annual connection charge rate of return at CUSC 14.3.21 to price control cost of capital'

4870. MPS from National Grid Electricity Transmission (NGET) delivered a presentation on PM0113. MPS stated that PM0113 proposes to align STCP14-1 with CUSC Modification CMP306 by requiring Onshore TOs to confirm their respective pre-tax RoR (Rate of Return)/WACC (Weighted Average cost of Capital) for Transmission Connection Assets as part of the annual charge setting process, as well as stating this pre-tax Rate of Return/WACC and the calculation methodology in the TO's respective Statement of the basis of transmission owner charges document.

- 4871. RW sought confirmation on who from National Grid ESO had been involved with the drafting of this proposal due to the impacts it has. RWO confirmed that it was National Grid ESO who initially drafted the STCP proposal, however due to this not being raised NGET finalised and submitted the Proposal.
- 4872. The Panel discussed the timelines for this STCP and how this will work with CMP306. CB confirmed that the proposed steps going forward are for Panel members to confirm that they are content for the draft to be submitted to the Authority alongside CMP306, by 8 November 2019. The STC Panel will approve the STCP for implementation if CMP306 is approved by the Authority as this is a consequential Modification.

PM0114 'STCP21-2 Network Asset Risk Metric (NARM) Data Exchange'

4873. The Panel discussed the draft and agreed to submit it to the Authority for their review following any final comments being received by 8 November 2019. The Panel noted the Governance Rule 7.3.2.3 the amendment or addition does not impose new obligations or liabilities or restrictions of a <u>material nature</u> on Relevant Parties which are not subsidiary to the rights and obligations of the Relevant Parties under the Code. As the ESO have stated that this will have a material impact on them it will be submitted to the Authority for them to determine whether the STCP should be progressed. The Panel will then await their decision on whether to proceed before approving the STCP.

5. Potential Future Modifications

Modification Tracker and Horizon Scan

- 4884. RF stated that she will no longer be attending the STC Panel as the Ofgem representative, she advised that her colleague Jonathan Coe will be attending the Panel going forward.
