## **Key areas of discussion**

- The Proposer, SHEP-D, provided the Workgroup with a summary of the purpose of CMP337/CMP338.
- The ESO provided the Workgroup with a Charging Refresher of the Wider TNUoS
   Tariffs. The Workgroup also discussed the effect of the contribution on MITs Node
   Charging scenarios to ensure it was transparent and non-distortive. The Workgroup
   looked at three different Charging scenarios:
- Local Circuit Recovery,
- Zone 1 Wider TNUos recovery &
- New Zone for Shetland wider TNUos recovery.



- Further analysis/clarification was requested, which the ESO has taken away actions to complete ahead of the next Workgroup.
- The Workgroup considered any overlaps with the two Modifications that are with the Authority for a decision, these being CMP320 'Island MITs Radial Link Security Factor' and CMP303 'Improving local circuit charge cost- reflectivity'. The Workgroup agreed that CMP337/CMP338 has no direct impact on these Modifications, however acknowledged that the Modifications look to amend the same section of the CUSC, which could later result into a housekeeping change if all Modifications are approved.
- The Workgroups held discussions around the proposed timetable, which had been approved by the CUSC Panel and Ofgem. Some Workgroups members felt that a longer Workgroup Consultation should be held to give Industry further time to respond. The Code Administrator confirmed they would take this offline and report back at the next meeting.

The next Workgroup will be held on 20 April 2020.
