1195. It was agreed that CAP158 should proceed to Consultation for 4 weeks.

5 Standing/Working Group Reports

- 1196. **BSSG (Balancing Services Standing Group)** DB gave a verbal update on the good progress being made at the Standing Group. DB outlined that the group is currently focusing on frequency response and reactive power. The next meeting of the Standing Group will be held in five weeks time.
- 1197. TASG (Transmission Access Standing Group) HR gave a presentation. Slides can be found on National Grid website see link below http://www.nationalgrid.com/NR/rdonlyres/5BA2EB95-CFDB-4341-A0AB-E85C2BF35F6C/19713/TransmissionAccessStandingGrouppresentationto31Aug.pdf PJ agreed that the Terms of Reference have been completed and that the report was a fair reflection of the groups debate. TD questioned how the Standing Group Report would interact with the Transmission Access Review (TAR) to ensure the good work of the group was not wasted or repeated in the review. SC agreed to write to the TAR group to formally submit the Standing Group's report and offer a sub set of the Panel Members who had attended the Standing Group to assist, if required.
- 1198. CUSC Amendments Panel Chair to write to the Transmission Access Review to submit the TASG report as an input for the review.

Action SC

- 1199. The Panel agreed that the Terms of Reference for the Standing Group have been completed and the group should be disbanded.
- 1200. CAP148: Deemed Access Rights to the GB Transmission System for Renewable Generators MT gave a presentation. Slides can be found on National Grid website see link below http://www.nationalgrid.com/NR/rdonlyres/548724FC-8D71-4303-8F10-4726CAD70ED3/19716/CAP148wgreportAUG07final.pdf. SC asked the Panel to consider if the issue surrounding discrimination and cost of carbon had been considered fully by the Working Group. GG indicated that he would be responding to the consultation independently on the legality of CAP148. PJ believed that even if the Working Group were given more time the group would be unlikely to develop further arguments within the CUSC framework. TD stated that the Working Group received lots of legal and technical advice and believes the wider debate surrounding legality and Ofgem's role are not within the remit of the Working Group.
- 1201. MT as chair of the Working Group gave an overview of the discussions and outlined how difficult CAP148 was to assess against the CUSC Applicable Objectives as the proposal has a wide reaching impact. BB believed there was enough information within the report for parties to form a view about CAP148.
- 1202. DC stated that time and effort could have been saved if the regulator had given a preliminary view on CAP148. DC believes additional paragraphs should be added to the report to reflect the groups' discussions on the wider aspects of the amendment surrounding discrimination, even though such views are strictly outside the CUSC

- Applicable Objectives.
- 1203. DB stated that Ofgem would have been unable to provide a preliminary before the Working Group had concluded as the details of the amendment had not been fully discussed and developed. DB also agreed with DC that additional paragraphs should be included within the report to facilitate consultation respondents giving their view on the issue of discrimination.
- 1204. GG suggested that the legal meaning of discrimination would therefore need to be defined within the report. SC suggested such information should be within an annex. GG also had a query relating to the legal text.
- 1205. The Panel agreed that the Working Group should amend the report to add additional information regarding the assessment of due and undue discrimination and clarify GG legal text query. To be completed by the Working Group next week for CUSC Amendment Panel approval via e-mail prior to Consultation by National Grid.

 Action MT, CAP148 Working Group and Panel members
- 1206. MT provided an overview of the process from the chairman's perspective and stated that CAP148 was difficult to assess due to the charging, discrimination, environmental implications. Despite the difficulties MT believed the group contributed fully to the debate. MT found it difficult to link the wider environmental objectives to the CUSC Applicable Objectives.
- 1207. MT stated that as the assessment was bound by the CUSC Objectives he did not believe it was the optimal solution and this should be brought to the attention of TAR.
- 1208. PJ stated that CAP148 was only to be assessed against the narrow framework of the CUSC and it was not the role of the CUSC Amendments Panel to speculate over government policy. PJ believed that the report reflects this well and is not suboptimal solution based on the current framework.
- 1209. PJ stated that the environmental objectives do not for part of the CUSC Objectives since they are covered elsewhere (i.e. EU ETS, CCL and ROCs) and Ofgem's letter was not helpful in that aspect. TD agreed with this statement.
- 1210. GG reminded the Panel that there are four key energy goals that form the Government's energy policy (as laid out on page 6 of the May 2007 Energy White Paper) and that promoting renewables in preference to none renewable generation is not one of them. Therefore we need to be mindful of not inferring what Government energy policy is from comments, aspirations, targets, ideas, views etc., that are adduced as being Government energy policy.
- 1211. **CAP149 TEC Lite** TD gave a verbal update on the good progress being made by the Working Group, highlighting the issue that CAP149 may not necessarily require a new access product called TEC Lite. TD intends to have the report ready for the September Panel meeting.
- 1212. CAP150-155 Capacity Reduction: Construction Agreements Works Register: Exhibit D, B, F & I revisions. – DB gave a verbal update on the good progress of the Working Group.
- 1213. **CAP157 Extension of Qualified Company Definition –** BB gave a verbal update

on the good progress of the Working Group and identified no significant issues have been raised so far, if this remains the case the Working Group report may be ready for the September Panel meeting.

1214. The Terms of Reference were presented to the Panel and agreed subject to changes to the generic elements see AOB.
