# 1 Summary

## Defect

### Exhibit Y

On 23 June 2020, the Authority approved CUSC Modification CMP323 'Updating the CUSC governance process to ensure we capture the EBGL change process for Article 18 Terms and Conditions'. It has been identified that that Exhibit Y of the CUSC (Mapping Table) was not included within the approved legal text - therefore this modification seeks to insert this.

### Section 6

It has also been highlighted by Industry participants that Section 6 (General Provisions) of the CUSC has incorrect numbering and as such, this needs to be amended.

## What

### Exhibit Y

CMP323 'Updating the CUSC governance process to ensure we capture the EBGL change process for Article 18 Terms and Conditions' was approved by the Authority on 23 June 2020 with an Implementation date of 25 June 2020. CMP323 implemented changes to Section 4 (Balancing Services), Section 8 (Governance Rules), Section 11 (Interpretations and Definitions) and introduced Exhibit Y (EBGL Mapping Table). However, Exhibit Y (EBGL Mapping Table) was not submitted as part of the CMP323 legal text. The Proposer of CMP323 confirmed that this had no material impact on the implementation of CMP323; , however, this should be included as this provides transparency for industry parties as to whether or not a CUSC Modification will require a consultation in accordance with the provisions of EBGL.

### Section 6

It has also been noted by industry participants that the numbering in Section 6 (General Provisions) is incorrect. The incorrect numbering is within Section 6.11 – Nuclear Installations, where the paragraph numbering references 6.10.

## Why

### Exhibit Y

Exhibit Y is needed in the CUSC as part of the EBGL process.

### Section 6

The numbering in Section 6.11 is inconsistent and should be amended for clarity.

## How

It is proposed that a Fast Track Self-Governance Modification is raised to insert Exhibit Y and amend the numbering in Section 6 of the CUSC.

## 2 Governance

### Justification for Fast Track Self-Governance

The Proposer recommends that this Modification follows the Fast Track Self-Governance procedure as the changes meet the required criteria as the Modification is required as a result of factual change, including but not limited to:

- i) Updating names or addresses;*
- ii) Correcting minor typographical errors;*
- iii) Correcting formatting and consistency errors, such as paragraph numbering, or;*
- iv) Updating out of date references to other documents or paragraph

The Self-Governance criteria is met as the modification is unlikely to discriminate between different classes of CUSC Parties and is unlikely to have a material effect on:

- i) Existing or future electricity customers;
- ii) Competition in the generation, distribution, or supply of electricity or any commercial activities connected with the generation, distribution or supply of electricity,
- iii) The operation of the National Electricity Transmission System
- iv) Matters relating to sustainable development, safety or security of supply, or the management of market or network emergencies
- v) The CUSC's governance procedures or the CUSC's modification procedures

For information, Fast Track Self-Governance – Guidance

- Rectify internal inconsistencies
- Remove outdated (or redundant) information;
- Correct typographical errors in the CUSC; or
- Further development / detail existing processes or code arrangements (without introducing new requirements upon code parties which significantly impact business practices or systems).

### Requested Next Steps

This modification should:

- be subject to Fast Track Self-Governance

## 3 Why Change?

CMP348 will insert Exhibit Y into the CUSC and amend the numbering in Section 6 to ensure consistency.
