### 1 Summary

### Defect

Multiple clauses within STCP 18-1 are required to be modified to ensure the ENA proposed interactivity process is enabled.

### What

Following a review, the proposal is to make updates to:

- Key Definitions- To clarify the new Interactivity terminology
- Early warning clause which will, where possible, allow NGESO to give early indications to the User about potential interactivity of their offer
- Other minor process amendments

### Why

By amending the proposed clauses, this will allow the Transmission Owner (TO) and Electricity System Operator (ESO) to fulfil their obligations in the Interactivity process that has been agreed with the ENA.

Interactivity: There are occasions where National Grid Electricity System Operator (the ESO) receives two or more applications for connection which makes use of the same part of the network but where not all the applicants can be connected without reinforcement. The resulting connection offers are referred to as Interactive Connection Offers. Interactivity is the process through which the TO and ESO determines which application will be able to connect or have priority of access to the future or existing network. Interactivity can be in relation to different aspects, including network capacity (such as circuit ratings and switchgear fault level capability), point of connection, and application of constraint within an Active Network Managed 'Last In First Off' queue. More details of all the ENA consultation and stakeholder engagement can be found here

### How

By updating existing clauses and inserting new clauses in STCP18-1.

### 2 Governance

Section B 7.3 states amendments for an STCP need approval from the STC Modification Panel. The Proposer recommends that this modification should be approved and implemented in line with the timetable.
