1. Introductions and Apologies for Absence

5044. Apologies were received from Nicola Bruce, Adam Brown and David Lyon.

2. Approval of Minutes from Previous Meeting

5045. The Panel approved the minutes from the meeting held on 24 June 2020. The Panel Secretary will update the minutes and arrange publication of the minutes. **ACTION**

3. Review of Actions

5046. The Panel reviewed the open actions from the meeting held on 24 June 2020 which can be found on the Actions Log.

4. Authority Decisions

- 5047. JG advised the Panel that there had been no Authority decisions on STC modifications, however, advised the Panel that Ofgem submitted a revised implementation date for CUSC modification CMP306 'Align annual connection charge rate of return at CUSC 14.3.21 to price control cost of capital' which has an impact on STCP14-1. JG confirmed that the implementation date is now 1 April 2021, instead of 30 October 2020. The Ofgem revised implementation letter can be found via the following_link.
- 5048. JC advised the Panel that as <u>CM074</u> 'Modify the definition of Force Majeure' was raised on the STC, Ofgem expect the consequential CUSC Modification to be raised and submitted to Ofgem at the same time for a decision. It was confirmed that the ESO are working with the Proposer of CM074 to ensure the CUSC Modification is aligned.

5. STC Modification Proposals for discussion

Amendments to STCP13-1 Clause 3.2 - Changes to TO Site Specific Charges

- 5049. RWO from National Grid Electricity Transmission (NGET) provided an overview on a potential change to STCP13-1 '*Invoicing and Payment*'.
- 5050. RWO explained that this change would amend STCP13-1, clause 13.2 'site specific charge' to decrease the formal notice period needed by the ESO from three months to one month, for the Onshore Transmission Owners to amend their Site-Specific Charges forecast within year. RWI advised that ESO are supportive of this change.
- 5051. RWO advised the Panel that he would look to formally raise this at the next STC Panel meeting.

STC Modification Proposals for Panel Decision

PM0113 'Update STCP14-1 'Data Exchange of charge setting' to reflect CUSC Modification CMP306 'Align annual connection charge rate of return at CUSC 14.3.21 to price control cost of capital

5052. The STC Panel held their determination vote on <u>PM0113</u>. The Panel unanimously agreed that PM0113 better facilitated the Applicable STC objectives and as such should be implemented by 5 August 2020.

6. Potential Future Modifications

5056. JC advised that Ofgem are starting to receive code modifications for Ofgem to evaluate and form a decision on.

5059. MD stated that the next NAP Workgroup meeting will be held in September 2020.

Transmission Charging Review Group - TCRG

5060. RWO stated that the next TCRG meeting will be held on 16 September 2020. RWO advised that the work that TCRG are reviewing could impact the STC, and as such future STC/STCP modifications could be raised.

5061. JG opened the Panel discussion on the Terms of Reference for TCRG. It was agreed that this would be looked at offline by RWO and any changes would be presented at the September Panel meeting for Panel approval. **ACTION**

9. Any other Business

TNUoS Cashflow Timing Risk

5063. RWO advised the Panel that this has been raised on the back of an Ofgem decision. RWO stated that the timing risk will be with the TO's rather than the ESO and wanted confirmation on if any STC changes are needed as a result of this decision. RWI advised that he thought this was a license change and not a code change, however, will take away and confirm. **ACTION**
