# New / Pending Authority Decisions

Ofgem have provided updates on the following modifications:

#### GC0142 and GSR026

To avoid any delays on the decision for GSR026 (equivalent SQSS modification) and **GC0142** - 'Adding Non-Standard Voltages to the Grid Code' Panel decided that GC0142 should go to Draft Modification Report stage due to the modification having non-material changes. Ofgem are looking to publish their decision by mid-November 2020.

# GC0130 – 'OC2 Change for simplifying 'output useable' data submission and utilising REMIT data'

**Panel Decision:** Approval of revised implementation date from 27 November 2020 to 02 February 2021 was provided.

### GC0121 - 'Grid Code changes in the event the UK leaves the EU without an agreement'

**Panel Decision:** To proceed to Code Admin Consultation after amended Legal Text has been reviewed by Panel via circulation.

#### GC0142 - 'Adding Non-Standard Voltages to the Grid Code'

Panel Decision: Panel decided that as the modification has no material changes and therefore does not need to be reissued for a Code Administrator Consultation. NGESO to make required amendments to Legal Text in line with decision letter from the Authority. The Code Administrator will then arrange a special panel meeting to conduct another recommendation vote before issuing the final modification report to the Authority.



# GC0136 – 'Non-material changes to the Grid Code following implementation of the EU Connection Codes'

Panel Decision: Approved by Panel to proceed to Code Administrator Consultation.
