1) Minutes of Previous Meeting

The minutes of the CUSC Amendments Panel Meeting held on 24 September 2010 were APPROVED subject to additional comments from Ofgem and will be published on the Company website shortly.

2) New Amendment Proposals

No new Amendment Proposals were raised at this Panel meeting

3) Industry Code Updates

CAP179 – Prevention of "Timing Out" of Authority decisions on Amendment Proposals. The Panel AGREED that the CAP179 Working Group had fulfilled its Terms of Reference and that CAP179 should proceed to The Company Consultation for two weeks.

CAP182 - Provision of Frequency Response from DC converters. The Panel noted that the Authority was minded to reject the similar BSC modification; P259 and therefore CAP182 may be withdrawn by the proposer subject to the publication of the decision on P259.

4) Authority Decisions

The Amendments Panel noted that the following Amendment Proposals were APPROVED by the Authority:

5) CUSC Amendments Panel Vote

CAP183: Code Governance Review – Significant Code Review. The Panel voted with a 5-3 majority that CAP183 should be implemented.

CAP184: Code Governance Review – Self-governance. The Panel voted unanimously that CAP184 should be implemented.

CAP185: Code Governance Review - Role of Code Administrator and Code Administration Code of Practice. The Panel voted that both the original proposal and Working Group Alternative better facilitated the Applicable CUSC objectives but with a majority preference that the original proposal should be implemented.

CAP188: Code Governance Review - Governance of Charging Methodologies. The Panel voted that both the original proposal and Working Group Alternative better facilitated the Applicable CUSC objectives but with a majority preference that the original proposal should be implemented.
