New Modifications

The were no new modifications raised for November 2020.

New / Pending Authority Decisions

Ofgem have provided updates on the following modifications:

GC0131 'Quick Wins' Improvements to Grid Code Open Governance Arrangements

Decision was received 11 November 2020 - This was implemented on 26 November 2020.

GC0142 Adding Non-Standard Voltages to the Grid Code

Decision was received 15 October 2020 (send back) and further work was required by the Authority on the Legal Text. The Code Administrator held a Special Panel Meeting on 16 November to carry out a recommendation vote after the changes had been made by the ESO. The Grid Code Panel unanimously recommended that the **Original** better facilitates the Grid Code Objectives than the Baseline. Final Modification Report will be issued to Ofgem on 19 November 2020.
