




#### Introduction

- CUSC KPIs were introduced in October 2009
- The KPIs cover two areas:
  - CUSC Modifications KPIs to monitor progression of proposals through the CUSC Modifications process
  - CUSC Modifications Panel KPIs to measure performance of administration of the Panel
- The KPIs are reported to the CUSC Modifications Panel each month, on a retrospective basis

Green	Number of CUSC Modification Proposals (CMPs) taking equal to or less time than initial timescales agreed by Panel	Panel accepts Workgroup recommendation to move to Company consultation		
Amber	Number of CMPs taking longer than initial timescales agreed by Panel, but variation agreed by Panel Members	Panel rejects Workgroup recommendation to move to Company consultation but not due to failure of analysis, Terms of Reference, process or presentation		
Red	Number of CMPs taking longer than initial timescales agreed by Panel, with no agreed variation by Panel Members	Panel rejects Workgroup recommendation to move to Company consultation due to failure of analysis, Terms of Reference, process or presentation		
Implementation: Green as per agreed timescales Red later than agreed timescales				



- CAP181– Consequential changes related to Grid Code Amendment A/10 (Compliance)
  - Date raised: 18<sup>th</sup> February 2010
  - Date Panel decision to proceed to Workgroup: 26<sup>th</sup> February 2010
  - Workgroup Consultation released 23<sup>rd</sup> June 2010 with a closing date of 7<sup>th</sup> July 2010, six responses were received
  - Second consultation being proposed for the Grid Code Amendment with a possibility of National Grid withdrawing CAP181 as it may no longer be required



- CAP182 Provision of Frequency Response from Direct Current (DC) Converters
  - Date raised: 13<sup>th</sup> May 2010
  - Date Panel decision to proceed to Workgroup: 21<sup>st</sup> May 2010
  - Workgroup Consultation released 16<sup>th</sup> July 2010 with a closing date of 5<sup>th</sup> August
  - Proposer withdrew its support for CAP182 due to further clarity being provided about the European Third Package
  - CAP182 officially withdrawn and timescales for adoption of Proposal expired on 8<sup>th</sup> December 2010



- CAP189 Standard Gas Insulated Switchgear Ownership Boundaries
  - Date raised: 22<sup>nd</sup> July 2010
  - Date Panel decision to proceed to Workgroup: 30<sup>th</sup> July 2010
  - Workgroup meeting held on 28<sup>th</sup> September 2010
  - Second Workgroup to be arranged, awaiting legal text drafting



- CAP190 Two Thirds Majority Voting requirement for CUSC Panel recommendations on Amendments arising from Licence obligations Authority requests or obligations
  - Date raised: 26<sup>th</sup> August 2010
  - Date Panel decision to proceed to Workgroup: 3<sup>rd</sup> September 2010
  - Workgroup meeting held on 23<sup>rd</sup> September 2010
  - Joint BSC P264/CAP190 telephone conference meeting held on 27<sup>th</sup> October to discuss the legal brief for the QC
  - Meeting arranged for 21<sup>st</sup> January 2011 with the QC to discuss the legal brief
