Key areas of discussion

- CMP298 seeks to introduce a more efficient aggregated assessment of Distributed Generators (DG) that have or may have an impact on the National Electricity Transmission System (NETS). This process (known in the industry as the Appendix G process) has been been trialled by Network Operators over the last few years and the learning from this will be applied to the CMP298 change. This new process will sit alongside the current process (the Statement of Works process) with a small change being applied to this existing process to clarify that multiple projects can now be applied for at the same time.
- The first part of the meeting was spent reacquainting the Workgroup with previous discussions.
- The Chair presented a revised timeline. This was further amended by the Workgroup as it was clear that further review time for some of the key documents needed to be built in. The Workgroup agreed the end to end timeline, which is attached to this summary. The Workgroup Report will be presented to the June 2021 Panel.
- The Proposer presented the latest User Guide (the "Product Document") setting out the key characteristics of the processes and draft Legal text. Further work is required on both the Product Document and draft Legal Text specifically:
 - On the Product Document more use of plain English and consistency with the guidance/terminology that the Open Networks have used so it is clear for Network Operators applying this going forward. The Workgroup were also keen that the Product Document is explicit that the new process has moved away from the ESO providing

defined amounts/blocks of capacity to a more considered approach in line with planning limits.

- **On the Legal Text** Workgroup Members felt that they could only properly assess this once the Product Document had been updated.
- The Chair presented the Terms of Reference with a view to checking they remained fit for purpose. No changes were proposed; however, some additions to the draft Workgroup Consultation will be needed to ensure these are all covered off.
- Implementation date and approach needs to be discussed at the next Workgroup meeting e.g. is a transition period needed for Network Operators to update their processes/training? or what happens for those sites that are progressing through the existing Statement of Works process?
