Detailed below is a summary of the key changes made to the consultation documents.

Dynamic Containment - Document Update Summary of Principal Changes

Auction Rules [previously titled Tender Rules]

Throughout	Terminology	DC Tenders changed to DC Sell Orders, tender process changed to Auction, NGESO website changed to Designated Auction Platform
1.1	Introduction	Updated to address change to EFA Block auctions
5	DC Buy Orders	New paragraph, to refer to submission by NGESO to EPEX prior to auction closing time of a buy order for each DC Product and EFA Block
6.1 – 6.3 and 6.5	DC Sell Orders	Previously paragraph 5 (DC Tender Submissions), new address submission of DC Sell Orders (per DC Product and EFA Block) during rolling 13 day auction window (D-14 to D-1)
6.4 and 6.6	DC Sell Orders cont.	Introduction of linking via block codes (parent/child), similar to those for response auction trial
6.7 – 6.12	DC Sell Orders cont.	Introduction of rules similar to those for response auction trial
6.13 and 6.14	DC Sell Orders cont.	Previously paragraph 7 (Disqualification of DC Tenders)
7	Market Clearing Rules	Explanation of market clearing process, similar to that for response auction trial (and replacing paragraph 8 (Tender Assessment))
9	Daily Auction Reports	Replaces paragraph 10 (Market Information), and set outs timing and content of NGESO's Daily Auction Report
10	Formation of DC Response Contracts	Previously paragraph 9 (Acceptance and Rejection), provides for the daily communication from EPEX with the auction results, which will form the response auction contracts, and clarifies that there will be one contract for each relevant EFA Block and DC Product.

Throughout	Terminology	All references to DC Service Day changed to Contracted EFA Block, to reflect fact that each contract is now for a single EFA Block/DC Product rather than for a service day
1.1	Introduction	Updated to address change to EFA Block auctions
3.3	Prevailing	The prevailing latest version of document changed to be that in force at the 'Auction Closing Opening Time' not the 'Auction Opening Time'.
6.3	Service Delivery (operational baselines)	Specific references to MEL/SIL and SEL/MIL for BM now removed
6.4	Service Delivery (operational baselines) cont.	For non-BM, explicit that NGENSO will not require submission of advance baselines until further notice
6.7	Service Delivery cont.	Further clarification to cover both LF and HF
12.6	Provision of Other Services	Clarification that DC can be 'stacked' across both DC Products
13	Communications	Non-BM operational baselines when applicable may be submitted by such means as NGENSO may direct (and so not necessarily via a data concentrator)
15.1	Monitoring and Metering Data	Clarification around contents of operational data
15.2	Monitoring and Metering Data cont.	As above, introduction of flexibility around use of data concentrator for operational data
15.4	Monitoring and Metering Data cont.	Clarification around performance baselines submitted as DC Performance Data
