New Modifications

There were no new modifications raised for May 2021.

New / Pending Authority Decisions

GC0144 - GC0144: Alignment of Market Suspension Rights to the EU Emergency and Restoration Code Article 35.1(b)

This was implemented into the Grid Code on 26 May 2021.

GC0147 - Last resort disconnection of Embedded Generation – enduring solution

This was Implemented into the Grid Code on 17 May 2021.

There was one DFMR presented to Panel for a recommendation vote

GC0133 - Timely information of the GB NETS System State Condition

This Modification will require the Transmission System Operator (TSO) for GB National Grid Electricity System Operator (NGESO) to inform, in a timely manner, the System State condition of the GB National Electricity Transmission System (NETS) to market participants.

The Panel by majority decided that the DFMR be sent back to the workgroup to further develop the requirements within the Ofgem decision letter as stated below:-

1. The benefits of the modification to market participants and stakeholders; and



2. The challenges to the ESO of providing this information, including the challenges of publishing the reasons for the changes of system state condition

Therefore, the Panel deferred the recommendation vote for a future Panel meeting once this work is fully completed.
