This note sets out the headlines and key decisions of the most recent meeting of the CUSC Modifications Panel under the CUSC constitution. Full minutes of the meeting will be produced and approved at the next meeting of the Panel and will then be published on the website.

1) Minutes of Previous Meeting

The minutes of the CUSC Panel meeting held on 26 October 2012 were APPROVED and will be published on the National Grid website shortly.

2) New CUSC Modification Proposals

None

3) Workgroup Updates

CMP201 – Removal of BSUoS Charges from Generation. Further to the Send-back direction issued by Ofgem² on 25 October 2012, the CMP201 Workgroup reconvened on 15 November 2012. The Workgroup Report is being redrafted and the Workgroup will re-take their vote, after which a second Code Administrator Consultation will be published. The Panel are due to re-vote on CMP201 at their meeting in March 2013 after which the Final Modification Report will be submitted to the Authority for a decision.

CMP213: Project Transmit TNUoS Developments. The Panel noted that two Seminars have been scheduled to take place to provide the industry with an opportunity to discuss the details of CMP213 and understand the key components. These are taking place on 11th and 12th December 2012 in London and Glasgow respectively. The CMP213 Workgroup Report is due to be presented to the CUSC Panel in February 2013.

4) CUSC Modifications Panel Recommendation Vote

CMP207 – Limit increases to TNUoS Tariffs to 20% in any one year. The Panel voted by majority that CMP207 and the four Workgroup Alternative CUSC Modifications do not better facilitate the Applicable CUSC Objectives and so should not be implemented.
