CMP217 - Clarification of the CUSC 'Interruption Payment' and 'Interruption Period' definitions

Background - CMP211 and CMP212

- CMP211 and CMP212 (both implemented on 24 January 2013) have introduced alignment in compensation calculations (CMP211) and process improvements (CMP212) for loss of transmission access claims
- The calculations for these claims are set out under Section 11 of the CUSC 'Interruption Payment'

CMP217 Defect

- Section 11 of the CUSC (Interruption Payment definition) sets out the calculations for:
 - 1) A Planned Outage
 - 2) An outage as a result of Emergency Deenergisation Instructions
 - 3) All other Relevant Interruptions
- The calculations as set out in the definition above can be difficult to follow. CMP217 clarifies the Interruption Payment and Interruption Period definitions such that the calculations can be followed more easily.

CMP217 Solution

- Clarification of Interruption Payment and Interruption Period so that it is easier to follow.
- To minimise industry resource it is proposed that CMP217 follows a self-governance and straight to consultation route.

CMP217 - Benefits of clarification

- CMP212 introduced process changes for Loss of Transmission Access Claims, it introduced a 30 day limit for Users to submit a claim, it also introduced an Interruption Payment Threshold. This threshold is currently set to £1 although there is scope for the Panel to increase it to £5,000.
- CMP217 will make it easier to calculate the payment which may be due for a claim, this will help users in the decision making process for claim submission.

Applicable CUSC Objectives

- (b) Facilitating effective competition
 - This proposal will better facilitate applicable objective (b), the modification will allow users, including those who may not be familiar with the calculations, to more easily derive the materiality of any loss of access claims.
