Approval of May Minutes

New STCP Modifications

PM0119: TNUoS Revenue Collection Risk Transfer

An <u>Ofgem decision</u> on 9 July 2020 means the cashflow timing risk of TNUoS revenue collection is being reallocated from National Grid ESO to the Onshore Transmission System Operators as part of licence changes. This STCP change was raised to facilitate the new processes and is required to be in place by 1 July 2021 when the licence changes take effect.

Before giving their approval vote, Panel members for NGET and SPT shared feedback that it is suboptimal that the STCP is being voted on the day before it is required to be implemented, and that the subsequent running of this process should be kept under constant review. It was suggested that this should also be kept as a standing item on the Transmission Charging Review Group. Before giving their reject vote, the Panel member for SHET shared a view that the process set out in the proposal is underdeveloped and does not give enough assurance to onshore TOs. The ESO member noted the feedback but stated that the drafting of the STCP had been carried out with representatives of each of the TOs, and that in working together on this every effort to accommodate their requirements in the time available had been made. This was acknowledged by the panel.

CM076 - STC change to reflect the terms of the UK's departure from the EU
