This note sets out the headlines and key decisions of the most recent meeting of the CUSC Modifications Panel under the CUSC constitution. Full minutes of the meeting will be produced and approved at the next meeting of the Panel and will then be published on the website.

1) Minutes of Previous Meeting

The minutes from the meeting held on 25 April 2014 were approved subject to changes and are available on the National Grid website.

2) New CUSC Modification Proposals

There were no new CUSC Modification Proposals at this meeting.

3) Workgroup Updates

CMP227 – Reduce the G:D split of TNUoS charges, for example to 15:85. CMP227 aims to change the G:D split, reducing the proportion of TNUoS charges paid by generators to a suggested ratio of 15:85. The Second Workgroup was held on 8th May 2014, with the next scheduled for 20th June 2014. The Workgroup requested an extension to the timetable for CMP227 and the CUSC Panel has agreed to a 1 month extension. The CMP227 Workgroup Report is now due to be tabled at the August Panel meeting.

4) CUSC Modifications Panel Vote

CMP222 – 'User Commitment for Non-Generation Users'. The Panel voted against the Applicable CUSC Objectives for CMP222 and voted by majority 5 out of 9 that WACM1 better facilitates the Applicable CUSC Objectives and therefore should be implemented.

CMP225 – 'Consequential changes following implementation of the Third Package and other miscellaneous changes'. The Panel voted against the Applicable CUSC Objectives for CMP225 and voted unanimously that CMP225 should be implemented.
