CUSC Modification CMP256

Potential consequential changes to the CUSC as a result of CMP244

November 2015







CMP256 Proposal

The Modification Proposal is to consider potential legal text changes caused by CMP244 which fall outside section 14, namely:

Section 3.14.3 "The Company shall give the User not less than 2 months prior written notice of any revised charges".

Section 11 which currently defines the TNUoS tariff forecasting timetable as "an annual timetable prepared and published by The Company by the end of January of each Financial Year (t) which sets out when The Company will publish updates in Financial Year (t+1) (being not less than quarterly) to the forecast of Transmission Network Use of System Charges for the Financial (t+2)".





Why is the Proposal needed?

Should CMP244 be approved, both section 3 and 11 would need to change to reflect the final agreed notice period and revised forecasting timetable agreed as part of CMP244.

However CMP244 was raised as a Charging Modification and therefore only section 14 of the CUSC can be modified.

A non-charging Modification needs to be raised to address sections of the CUSC outside section 14. However do not wish to duplicate any existing work taking place under 244 (256 simply reflects 244 and does not introduce any new aspects).





Possible way forward?

If CMP256 raised today, the Modifications could be considered as being processed 'in parallel' with all relevant issues being dealt with through the existing CMP244 Workgroup.

Depending on whether any CMP244 alternatives are raised, potentially CMP256 could then report to the CUSC Panel when CMP244 reports, and both Modifications could go to Code Administrator Consultation together.





Applicable CUSC Objectives

a) The efficient discharge by the licensee of the obligations imposed upon it under the Act and by this licence;

National Grid is obliged to comply with Modification Proposals approved by the Authority and integrated into the CUSC. Where the two do not align as intended then this leads to inefficiency and a lack of clarity for CUSC parties.

b) Facilitating effective competition in the generation and supply of electricity, and (so far as consistent therewith) facilitating such competition in the sale, distribution and purchase of electricity;

Generators and Suppliers pay TNUoS charges to access the National Electricity Transmission System. These costs end up in the final prices passed on to GB consumers. The proposed changes herewith will bring greater clarity in the CUSC to the notice period Suppliers and Generators will receive for their TNUoS tariffs, and to the forecasts they will receive ahead of final tariffs being published. This will enable both Generators and Suppliers to more clearly account for the impact of TNUoS costs into their prices, reducing uncertainty and thus improving competition.








Possible way forward?
