# 17<sup>th</sup> May 2001

## **Membership proposals for Grid Code Review Panel**

- 1. At the meeting of the GCRP on 8<sup>th</sup> February, paper GCRP 01/05 was presented by NGC to initiate a discussion about any necessary changes to the Panel membership post NETA.
- 2. A number of views were expressed, with a number of Members wishing to maintain the "status quo". The discussion concluded with an action on NGC to return to the following meeting with a paper containing proposals for changes to Panel Membership.

#### Issues for consideration

3. Groups of Users requiring consideration are:

Generators
Network Operators
Non-Embedded Customers
Suppliers

## 4. Generators

There is currently a somewhat artificial split between companies with Large Power Stations with a total capacity above or below 5GW. There was concern about reducing the number of representatives. NGC's proposal is to eliminate this distinction such that the representation comprises:

- 4 persons representing those Generators with Large Powers Stations
- 1 person representing those Generators without Large Power Stations

#### 5. Network Operators

The simple solution is to replace the 3 PES representatives with 3 representatives of the Network Operators, recognising the PES licence split.

#### 6. Non-Embedded Customers

Non-Embedded Customers have similar obligations under the Grid Code to Network Operators, but are not currently represented. It is proposed that there should be one representative of Non-Embedded Customers.

## 7. Suppliers

It is proposed that there should be one representative of Suppliers to recognise the impact of the PES licence split and the increased impact of the Grid Code on this group post NETA.

## **Conclusions**

8. The current and proposed make-up of GCRP membership is summarised in the following table:

It should be noted that the number of Panel Members would increase by two.
