

## **European Industry Framework Activities**

## Introduction

Following a request from JESG, the below table sets out the main activities that the European Industry Frameworks team are currently leading on. These activities are driven by legislation that has been adopted into UK Law via Statutory Instruments. Note that this table is not extensive, and there may be other activities that are covered elsewhere.

Achieving compliance has a negative impact on consumer costs. NGESO have run a consultation with industry who broadly agree but also suggest reviewing longer-term options. We are investigating these and discussing with Ofgem.
		6.4	Utilisation of specific balancing products (as dictated by the EBGL Article 26 process) should be Pay as Clear. Only the BM and STOR were covered by this pre-Brexit and a derogation was approved to ensure they could remain Pay as Bid	All GB balancing products are now deemed specific (removal of EBR related articles, but left in reference within CEP), means that a Pricing Proposal (or derogations) is required to ensure compliance. NGESO have developed a Pricing Proposal with industry and plan to run a formal consultation.

SOGL - REGULATION (EU) 2017/1485	2019 No. 533	-	Sets minimum system security, operational planning and frequency management standards to ensure safe and coordinated system operation across Europe	Retained within GB Law with some amendments and revoking some requirements. SOGL 118/119 is progressing as this is still a requirement.
EBGL - REGULATION (EU) 2017/2195	2019 No. 532	-	Integration of balancing markets across Europe	Retained within GB Law with some amendments and revoking some requirements - now called Electricity Balancing Regulation (EBR)
		52	Imbalance harmonisation methodology required across Europe	Updating the methodology to be appropriate in GB. Proposal has been consulted upon and submitted to OFGEM. OFGEM approved methodology 16/12.
E&R - REGULATION (EU) 2017/2196	2019 No. 533	GC0148	Ensure security and continuity of electricity supply across Europe	Retained within GB Law with some amendments and revoking some requirements. Workgroups for E&R phase II (GC0148) are ongoing.
