### **Key areas of discussion**

### **Actions update:**

- The Proposer provided an update to the actions from Workgroup 12. For actions 3 & 4, the NGET Workgroup member agreed to provide detail for the Workgroup Report on the TO's commitment to be transparent in Charging Statements.
- The NGET Workgroup member advised the Workgroup that there is not a significant amount of delay charges currently. They provided rough figures for the past year and explained these were mostly due to the same projects delaying repeatedly.

#### Review of draft Workgroup consultation document:

- The draft legal text which was shared at the last Workgroup meeting by the NGET Workgroup member has now been incorporated into the Original Proposal. This wording helps to ensure that the TOs carry out a transparent process.
- A Workgroup member questioned whether CMP289 is still required. The proposer took an
  action to review the CMP289 solution and ensure the consultation document had a clear
  explanation of the modification changes, if required.

### Review of draft legal text:

 A Workgroup member raised the concern that the draft legal text shared was not explicit enough as to if delay charges to users would be based on the original Mod App timeline or based on the adjusted. The Proposer took an action to clarify the iterative charges paragraph within the legal text.
