Offshore Transmission Network Review (OTNR): Offshore Co-ordination update – Amy Wong, National Grid FSO

It was clarified that currently there is no date for the publication of Ofgem's consultation, but it is expected to be Q2.

TDR Update - Grahame Neale, National Grid ESO

GN shared a TDR update. See slides for more detail.

Discussion themes / Feedback

There was some discussion around the governance route for the modification to change where the fourth TDR band would be. It was proposed to go straight to Code Administrator consultation. RL commented that there could be resistance to this approach. GN stated that with a single and clear answer alongside developing visibility this approach could be warranted. PM stated that the governance route is a panel decision, but the modification legal text would need to be fully developed.

GN clarified that the ESO are likely to raise an additional modification to document the process for re-evaluating the number of and boundary between transmission bands for RIIO-3. This would be drafted soon and expected to be raised this summer.

TNUoS Taskforce verbal update - Grahame Neale, National Grid ESO

GN gave a TNUoS Taskforce verbal update

Discussion themes / Feedback

Current delay on publishing with a likely update expected by the end of next week. Ofgem extended thanks to the ESO for the work up to now on this and explained of the desire to get this right and current overlapping priorities. GN clarified that no change from FSO reform and continuing to work under current processes.

Billing system and new 5yr forecast

NE apologised for the delay in publishing the new 5yr forecast but confirmed it would be published 7 April with a webinar to follow next week. NE shared details of forthcoming sessions on the new billing system (STAR program) and the opportunity this will give stakeholders to talk to the ESO and enable any pain points to be captured.

CUSC mod - National Security and Investment (NSI) Act 2021

ND shared details of the need for changes to the CUSC to support the National Security and Investment (NSI) Act 2021. The reason for this change is the concern a hostile investor could build and operate an asset in a way to disrupt the energy network and impact security of supply. The National Security and Investment (NSI) Act 2021 enables Government to scrutinise the acquisition of rights in entities and assets and intervene where there is a risk to national security. Energy is one of 17 sensitive sectors to which the NSI Act applies, which includes downstream gas and electricity infrastructure. The proposed modification would allow information to be shared between NGESO and BEIS as required.
