#### 1. Introductions and Apologies

8990. Apologies were received from Christopher Smith, Nick Rubin, Steve Cox and Sigrid Bolik.

8991. The Chair reminded Panel Members of the requirement for impartiality and of declaring potential or perceived conflicts of interest.

#### 2. Minutes from previous meeting

8992. The meeting minutes from the Grid Code Review Panel held on 27 March 2022 were approved, subject to the incorporation of amendments requested by AC and RW.

#### 3. Review of actions log

8993. The Panel agreed to close Action **420**. AF noted that, at the last meeting, it had been agreed that the Code Administrator need to check and review the Terms of Reference template being used for all on-going Grid Code modifications to ensure that it is the most up to date version that reflects all recent code governance changes. JG agreed to take this action and revert to Panel at the next Panel meeting. **ACTION 421** 

#### 4. Chair's update

8994. There were no Chair updates.

#### 5. Authority Decisions

8995. GS advised that the decision on GC0138 would be published on 31 May 2022.

8996. GS provided an update on the <u>Government response to the Energy Code Reform</u> as outlined below:

- As a result of Energy Codes Reform, Ofgem will have a new strategic function. This
  function will require primary legislation which the government will introduce once
  parliamentary time allows.
- A Future System Operator (FSO), an expert, impartial body with a duty to facilitate net zero whilst also maintaining a resilient and affordable system will be created. The FSO will be publicly-owned to ensure that it is independent – not only of asset ownership and other commercial energy interests, but also from day-to-day operational control of government.
- To ensure clear strategic direction of codes alongside the FSO, the Authority will engage with stakeholders and establish and regulate code managers.

8997. Some Panel members expressed that specific information as to timelines, how the future Code Managers would be set up and the role of stakeholders and the stakeholder advisory forums would be useful to have. GS advised Panel members that Ofgem will publish an open letter in this regard later in the year. RWi noted that similar questions were raised at

the recent FSO and Energy Code Reform consultation response webinars run by BEIS and Ofgem and took an action to circulate the material from these webinars to the Panel. **ACTION 422** There was a suggestion that the Authority should set up periodic webinars or forums to disseminate information as available.

Post Panel note: RWi circulated the webinar report to the Panel on 28 April 2022.

8998. There were no new modifications presented to the Panel.

#### 7. In flight modification updates

#### GC0139 Enhanced Planning-Data Exchange to Facilitate Whole System Planning

9000. JG advised the Panel that two Workgroup meetings were pushed back due to delays with the development of legal text. JG presented a revised timetable for this modification to the Panel, noting and highlighting that the date changes will have no knock-on effect on the overall timeline. The Panel agreed to the changes. AC advised that a subgroup he participated in the workgroup meetings had been working on developing and finalising the legal text and they have made good progress.

#### GC0148 Implementation of EU Emergency and Restoration Code Phase II

9001. JG advised the Panel that the Workgroup would need a one-month extension and, in effect, the Workgroup Report will be presented to the Panel on 30 June 2022 and not 26 May 2022. JG presented a revised timetable for this modification to the Panel and requested approval for the timeline extension. The Panel agreed to a delay to 30 June 2022 and approved the updated timeline. RWi noted that there was a unanimous response from the Workgroup Consultation to transfer Distribution Restart from this modification to be considered as part of **GC0156**.

# GC0141 Compliance Processes and Modelling amendments following 9 August Power Disruption

7. JG advised the Panel that there is a need for an additional Workgroup meeting in May to hold a Workgroup Vote. The timeline was extended post-workgroup consultation to allow for quality review of the legal text. JG explained that the WAGCMS had been repackaged and finalised to a total of 14 WAGCMs each giving a set of options such that Ofgem will be able to make a single decision. It is planned to present the workgroup report to the panel meeting in May.

#### 8. Prioritisation Stack / Dashboard

9002. The Panel reviewed the prioritisation stack and agreed to make no changes. The updated Prioritisation Stack can be found in the Headline Report via the following link:

9009. RWi noted that the GCDF meeting scheduled for 10 May 2022 was cancelled due to a lack of agenda items. The GCDF meeting on 1<sup>st</sup> June 2022 will include an agenda item on the ESO's draft RIIO BP2 submission covering 2023-2025 for which the BP2 team have also scheduled a launch webinar on 4<sup>th</sup> May 2022. RWi took an action to circulate the link to register for the event to the Panel members. **ACTION 423**

#### 15. Standing Groups

#### **Distribution Code Review Panel Update**

9010. AC noted that the Distribution Code EU Brexit modification was being finalised for submission to The Authority. AC also noted that the public consultation on EREC P2 and EREP 130 are being developed, although these are more relevant to SQSS and have no direct impact on the Grid Code.

#### Joint European Stakeholder Group (JESG)

9011. JG advised that the last meeting was held on 26 April 2022. The next meeting scheduled 10 May 2022 was cancelled.

#### 16. Updates on other Industry Codes

9012. There were no updates for Panel.

#### 17. Critical Friend Quarterly Update

9013. JG stated that, between 12 January 2022 and 11 April 2022, the Code Administrator had received 1 Grid Code Modification proposals and 8 CUSC Modification proposals. The required Critical Friend checks were carried out and required communications were sent to the Independent Chair, the Panel and industry within agreed timescales (i.e. on the next working day after Modification Proposal Submission Date).
