This note outlines the key action points from the most recent meeting of the GB SQSS Review Group.

1. Apologies for Absence

 Apologies for absence were received from Cornel Brozio (SP Transmission), Andrew Hiorns (Review Group Chairperson), Bridget Morgan (Authority), Brian Punton (Scottish Hydro-Electric Transmission Limited) and Andrew Wainwright (National Grid).

2. Intermittent Onshore Generation

The Review Group noted that the next Industry Workshop was scheduled for 21st
 August 2007. At the workshop the results of the analysis of the three methodologies
 against the specified scenarios would be presented.

3. GSR002 – Housekeeping

- 3. The Review Group agreed to review the proposed GSR002 consultation document prior to its industry consultation for comment.
- 4. The Review Group agreed that it was important that the review timescales for the housekeeping changes and the offshore changes did not to coincide with each other as the offshore changes needed to be based on the GB SQSS updated with housekeeping changes.

4. Review Register

- 5. The Review Group noted that the Grid Code P2/5 Working Group had identified two new review areas as outlined as follows:
 - Review of the GB SQSS and P2/6 to investigate whether there would be any
 merit in bringing the two standards closer together, perhaps going as far as
 aligning them at the interface between Transmission and Distribution Systems.
 - Specify a methodology for Average Conditions for winter demand data.
- 6. The Review Group noted the possible review areas but noted that formal review request form would have to be completed prior to any analysis being considered.
- It was noted that SHETL would be submitting a review request form to analyse whether Chapter 2 (Design of Generation Connections) of the GB SQSS should be inclusive of economic incentives.
