Key areas of discussion

- CMP376 seeks to implement the queue management process into CUSC including introducing a right for the Electricity System Operator (ESO) to terminate contracted projects which are not progressing against agreed milestones. This was the 4th Workgroup but the 1st following the agreed pause for the Proposer to further consider the stakeholder feedback received and consider this in their revised Original Proposal.
- Chair explained why there had been a pause between Workgroup 3 and this Workgroup and the Proposer then walked through the revised Original solution, which was largely welcomed. In summary:
 - ➤ The concept of Tolerances and Cumulative Delay are no longer part of the solution;
 - ➤ Milestones are applied from the Connection Date rather than the date that the Construction Agreement was signed; and
 - ➤ Will apply to any new Applications and Modification Applications from the Implementation Date note that Offshore non-radial connections are not within scope (Offshore Radial connections are within scope) and will be covered by a separate Modification and the Proposer agreed to confirm, that for Bilateral Embedded Generator Agreements (BEGAs)¹, the Distribution rather than the Transmission Milestones will apply.
- The key points for the Proposer to consider are:
 - Making the evidence requirements and exceptions watertight so minimises risk of grey areas and appeals;

¹ User is connected to the Distribution System but also makes use of the Transmission system so needs to have agreements with both the Distribution Network Operator (Distribution Agreement) and the ESO (Transmission Agreement)

- ➤ Ensuring the Milestone durations are correct and considering having separate Milestone timescales for those projects that need an Environmental Impact Assessment and those who don't;
- Consider suggestion that later milestones should be changed (backdated from new connection date) as part of a Modification Application but the early milestones wouldn't rather than the current position of the Original proposal, which is to not change any of the milestones as part of a Modification Application

The Actions Log shows a full list of the specific questions for the Proposer to consider.

• The Workgroup agreed that changes are needed to the Terms of Reference given the Original has changed and these will be drafted ahead of the next meeting on 27 September 2022. CUSC Panel would then be asked to agree to these changes at their next meeting on 30 September 2022.
