Key areas of discussion

- GC0154 seeks to provide clarity to stakeholders by incorporating Interconnector ramping requirements into the Grid Code in line with the requirements of SOGL A119. This includes fulfilling both the Compliance and Operational aspects.
- The purpose of this Workgroup was to review and discuss the proposed solutions put forward by the Proposer and Workgroup that should be included in the Cost Benefit Analysis (CBA)
- The ESO Representative advised the Workgroup that on the TSO Engagement, the ESO met with
 the ENTSO-E and Chair of the Inter- Synchronous Area SG but due to time there was no discussion
 at the September meeting but there is a meeting early October so feedback will be shared in the
 next Workgroup.
- The Proposer gave an update to the Workgroup on the CBA with an indicative high-level timeline. The timescale for the CBA will be confirmed with the external consultant once appointed.
- The ESO SME shared further Operational examples (from August 2022) demonstrating the
 operational challenges in the Operational room. The Workgroup suggested costs and risks should
 be included in the CBA to provide clarity and feedback should be shared to the workgroup.
- The Workgroup reviewed and discussed all the potential solutions and agreed to include Market based, ramp managements, Dynamic and Static Options including the Status quo should be explored in the CBA. A workgroup member proposed that the scope of the CBA needs to be clear in terms of costs and assumptions. Workgroup members expressed interest in ad-hoc meetings with the external consultant to have further discussions around CBA.
- The Chair advised the Workgroup on the timeline for GC0154, as this will be shared with the Workgroup as soon as the CBA timeline has been confirmed with the external consultant.
- The workgroup is mindful of being fully compliant at the earliest opportunity and are aiming to send recommendations to Ofgem by April 2023.
