Key areas of discussion

- The aim of this meeting was to go through the Consultation document and agree the
 workgroup consultation questions, taking into account comments from workgroup members
 which had been received, and also for the ESO Representative to share an update on the
 potential WACM.
- The Proposer explained that CMP398 proposes to introduce a codified cost recovery mechanism to prevent the affected parties being commercially disadvantaged by the implementation of the new obligations.
- The ESO representative talked through raising a potential WACM on the following;
 - It doesn't have annual opex allowance by technology type and size that the Proposer's modification has. It's a capex mod.
 - Claims to be submitted to and assessed by the ESO, no claims committee
 - o Generators commissioning after GC0156 is passed, cannot claim
 - September 2023 is ruled out as a first claims window. So, the first claims window is almost certainly September 2024 if it is passed. Most claims should have been processed by March 2025.
 - The ESO still considers the baseline to be best; this is better than original version of the modification.
- The workgroup had some discussions around this potential WACM, it didn't seem to get support from the workgroup, a workgroup member raised some concerns around capital costs arising.
- The Workgroup reviewed and discussed the workgroup consultation, finalised the consultation questions and agreed that the consultation should be issued on 3 January 2023.
- The Workgroup Report will be presented to March 2023 Panel.
