## **Outstanding Change Requests**

The relevant User Group has classified all of the above STCPs as being appropriate to be incorporated within Schedule 2; that is to say it has been categorised as either Category 1 or 2 STCPs<sup>1</sup>. A number of these STCPs have outstanding Change Requests that are still to be incorporated. However these Change Requests are not considered by the User Groups to be crucial for Go-Live and as such they will be incorporated into the STCP shortly after Go-Live through the enduring STCP Change Management process.

The STC Committee is invited to

- APPROVE that the STC Committee Secretary incorporate the above STCPs within Schedule 2 of the STC
- NOTE the publication of each of the above STCPs<sup>2</sup> on the Code Website
