56. The Committee NOTED the publication of the direction letter on 3rd March 2005 for implementation on 4th March 2005.

9 Transitional Issues - STC Procedures

- 57. NGC presented a paper on the incorporation of the STCP's into Schedule 2 of the STC.
- 58. The Committee AGREED to incorporate fourteen STCP's as identified by the relevant User Groups and attached in Appendix 1, into Schedule 2 of the STC.
- 59. The Committee NOTED that a number of these STCPs have outstanding change requests that require sign off. However these change requests are not considered by the User Groups to be crucial for Go-Live and as such they will be incorporated into the relevant STCP shortly after Go-Live through the enduring STCP Change Management process.
- 60. The Committee AGREED that the STCP's would not be published on the Industry Code Website until 1st April 2005. This will allow all parties to identify and agree on any potential confidentiality issues.
- 61. SPTL and SHETL to confirm to NGC by 31st March 2005, those STCPs or elements therefore that should remain confidential.

62. The Committee AGREED that a special meeting of the STC Committee would be convened on Thursday, 24th March 2004, in order to discuss the next batch of STCPS which will be ready for incorporation into Schedule 2. NGC is to prepare a paper listing the relevant STCPs.
