Key areas of discussion

Workgroup Objectives

Purpose of meeting was to review any showstopper comments on the legal text for the CMP376 Original, review any changes (and legal text) for the Workgroup Alternative CUSC Modifications (WACMs) and confirm that the Terms of Reference had all been addressed. If all of the above objectives were achieved, the Workgroup would proceed to the Workgroup Vote on 15 February 2023.

However, further work was still required on some of the WACMs (notably the ones that considered Dynamic Queue Management and legal text wasn't ready for all of the WACMs) and some of the Terms of Reference. Therefore, the Workgroup Vote will be delayed to 7 March 2023 and this will mean the Workgroup Report will now be presented to March 2023 Panel (rather than February 2023 Panel).

CMP376 Original Legal Text

Proposer addressed the showstopper comments on the legal text and agreed to provide a new version reflecting these changes.

Workgroup Alternative CUSC Modifications

Each proposed Alternative was again presented by the respective proposers and each proposer outlined any key changes since the last meeting. Associated legal text was then reviewed (although no legal text was yet available for WACM10 and WACM11).

In summary:

- Minor drafting changes are required for WACM 1 to WACM7 inclusive;
- Further discussion is required on the Dynamic Queue Management options (WACM8 and WACM9) on how this will work in practice including whether or not Completion Date should be used to determine queue position when first to contract is the current way; and
- Legal text for WACM10 and WACM11 still needs to be produced.

WACM8	Dynamic queue management for Milestones M5 to M8 - ESO's immediate right of termination is removed for Milestones M5 to M8 and replaced with the permanent reassignment of queue position Implementation Date – 6 months after Authority Decision		
WACM9	As WACM8 but applies as per WACM7		
WACM10	Introduces the concept of Proportionate Milestones (where the time between Offer sent and Completion Date is between columns on the Milestone Duration table, the actual milestone duration is calculated proportionately between the 2 column values).		
	Also allows Users to select which column their compliance with the Milestones is set out (but only where the Completion Date provided puts them in a Milestone category not suitable for their project). The project plan, that the User provides at time of application, determines what their actual milestone duration will be.		
WACM11	As per WACM1 and WACM8 and add Exception "Where a milestone is missed due to the User awaiting the award of a governmental or regulatory subsidy which provides financial support or incentive to the User's projects, the User may avoid termination if they can provide evidence that they are actively progressing with such a subsidy".		

² WACM7 was raised by the Proposer of the CMP376 Original. The test for Workgroup Alternatives is "Should the majority of the Workgroup OR the Chair believe that the potential alternative solution may better facilitate the CUSC objectives than the Original proposal then the potential alternative will be fully developed by the Workgroup with legal text to form a Workgroup Alternative CUSC modification (WACM)". Although it may seem odd that the Proposer of the CMP376 Original has raised an alternative rather than include the revised implementation approach in their Original proposal , this is not prohibited by the Governance rules under Section 8 of the CUSC and the Proposer of the CMP376 Original confirmed they would be keen to present both options to Ofgem.

³ In practice, it is unlikely that a project that is not progressing would not already have submitted a Modification Application to change their Completion Date.

Terms of Reference

The Chair sought views from the Workgroup as to whether or not all the Terms of Reference had been addressed. The majority of the Terms of Reference have been considered. However, further discussion is needed on the Terms of Reference entitled "Interaction with other provisions in the CUSC, Construction Agreements and Connection Agreements that deal with project delays and termination of agreements (e.g. Quarterly Updates)". Although CMP376 is adding a right for the ESO to terminate, the Workgroup sought clarity on how this additional right interacts with some of the existing provisions.

Cross Code Impacts

The Workgroup were appraised that the following STC changes may be required:

- Set out how and when the ESO will coordinate where ESO is seeking to exercise their right to terminate; and
- If any of the Dynamic Queue Management options are approved, the process for assessing the opportunities for other Users to benefit from the Delayed User moving down the queue.
