Discussion and Questions

1. SME slot – Balancing costs

January balancing costs: Filippos Panagiotopoulos talked through drivers of the month's balancing costs.

Question	ESO response
Adam – Are the minor components fixed yet? When will they be fixed, is there a timeline? Will it be fixed by the end of BP1 end of scheme? If not, we are going to have a significant error in balancing costs for the year in terms of the distribution of those costs for the end of year report.	Filippos: minor components are still not fixed and doesn't think it will be fixed any time soon and won't be for the end of BP1. Meaning the error will still be present in the end of scheme report.
Adam - Is there a threshold at which wind becomes a problem? That question is going to be very much dependent on system conditions, but is there a generality level of wind that starts to become problematic?	Filippos: Not sure at the moment but was going to look into this at some point in the future. Action: Jillian: Take away and try and answer that question in the BP1 narrative at end of scheme.
Adam - Is the manifest error; an error as in the data is wrong and you didn't spend it or that you spent it and the reason you spent it was caused by an error?	Jillian: I would say it was the latter of those 2 options

Adam - A follow on from that. The next most expensive action taken seems like it wasn't too far off that. Asked whether ESO knew which unit	Filippos: The really high-cost action added is not on the chart that you're looking at. Because it was so much higher than the rest of them.
the high cost instruction related to.	Filippos then shared his screen to show the complete chart, the really high-cost point, the settlement period and the date (25th Jan, SP31).
Adam - So was that an actual BOA instruction that someone acted on? And do we know who?	Filippos: Yes, this action was taken. We're currently investigating how that happened.
	Jillian: I don't have who to hand now, we do have that information just not with me.

3. Questions on Metrics/RRE's

James – Looking at Metric 2A it has been in the red year 2 so far compared to being green in year one. We need an explanation as to why this is the case in the end of scheme report.	Action: Discuss with Metric 2A Owner to make sure this explanation is part of the narrative in the end of scheme report.

4. Feedback on performance

Area	Feedback
Feedback on performance	James Hill and Adam Gilham re-raised concerns around NTC reporting. This has been raised by James over the last few meetings. ESO are slow to progress issues – after initial progress on reporting, work has stalled. Concerns still exist on this, and in relation to ESO submitting supporting evidence for a derogation request, is getting more concerning, OFGEM would like to see some action on improvements sooner rather than later as it is becoming a bigger issue as time goes on. Action: Simon to take away and find who can get a response around NTC to OFGEM

6. Review actions & AOB:

- 1. Milestones no longer valid: Work with all stakeholders to create a fully digitalised, whole system Grid Code by 2025 (A6.5). Simon provided an update and asked OFGEM for a decision on if this can be moved to no longer valid. Adam said he will have a chat with Gurpal to see what we know from our side. In terms of it descoping, even if it's agreed with stakeholders and Ofgem, I need to do a bit of thinking around whether the impact that has on the ambition of the plan. Given it's something that's not being done. Even if it's for good reason, it's you're then having to do less. Action: Adam to have a chat with Gurpal, in terms of a written approval from Ofgem.
- End of Scheme Report Key date updates. Simon gave an update on the dates related to the end of scheme events. Confirming they should now have placeholders for the in person panel event on 14th June and the virtual external stakeholder event to take place on Monday the 12th.

- 3. End of Scheme Report Phil confirmed there had been a value for money dip check session this week and had a meeting on CBA's and case studies and what OFGEM would like to see. Confirmed this was really useful in terms of telling us what you want to see in the final report. We might have more questions around this in the future. Also we might share some sort of proposed content or example CBA or case study, perhaps just to get OFGEM's feedback. And then you can kind of say yes, that's what we're looking for or we need to show a bit more.
- 4. 1A Benchmark Asked for an update from OFGEM regarding the benchmark in terms of the numbers and text. Adam confirmed he has put together the forst draft of text for the ESORI and double checked the numbers. Broadly happy where we are at the moment but just conscious that you could then add the last couple of months of it and it completely change the numbers. I think we're going to have to draw a line and cut it somewhere. Need to be clear if this will be continually reviewed or not be changed for the next 2 years. We can't be changing it every month cause then it doesn't provide any kind of certainty with reporting. Adam going to try and share something with us as soon as the wording is more certain. Phil asked; Do you have any more thoughts on excluding outliners? Adam said as we've got new data the rationale for that has fallen by the wayside. So, Adam thinks we could make an argument for excluding it. Phil then asked about bandings and Adam confirmed the current wording states this is 10% but if a better way is found to measure than it is subject to review and change. Action: Adam to provide dates and times available for a meeting to Phil. This is to discuss this further and make sure everyone is clear on what is coming out and what has been agreed going forward.
- 5. Other BP2 Performance measures Samar confirmed further discussions on 2A1, 2X and 3X connections metrics will be happening in the coming days and a proposal drawn up.
