Key areas of discussion

Review of Actions Log

The Workgroup agreed to close actions 64 through to 72.

• Action 64: An Ofgem representative stated that they would provide the Workgroup with an update re: questions on the CBA (cost benefit analysis) assumptions pending internal sign off, but no timeline was available

Queries on Control Telephony

The Workgroup discussed the levels of resilience referenced in the Control Telephony Standards and the technology type be used, with emphasis on improving Appendix 1 to reflect the requirements for different parties.

Review of Draft Workgroup Report

The Workgroup went through a consolidated draft Workgroup Report which has been built from feedback from Workgroup Members. The Chair asked for clarity on outstanding comments and worked through these live on the screen.

There were extensive discussions around the following topics:

- Using footnotes to best reference the change of names of Restoration Service Providers to Restoration Contractors and Department for Business, Energy and Industrial Strategy (BEIS) to Department for Energy Security and Net-Zero (DESNZ).
- Providing further context around what information had or had not been shared within the Workgroup relating to implementation costs and associated CBAs and questionnaires.

ESO

- The interlinking relationship between Distribution Restoration Zone Plans and Distribution Restoration Zones.
- Clearly differentiating between the technical requirements for all users (under the Original proposal) and the technical requirements for Restoration Contractors.
- Clarifying the expectation for parties to follow GC0156 obligations over the Fault Ride Through obligations from GC0151 until notified otherwise by the ESO.

Legal Text Check

TJ confirmed that the intention was to implement the legal text in full 10 working days after the Authority decision, with applicable dates being included e.g. 'from 31st December 2026' where required.

The Workgroup acknowledged that without a known resolution, the impact of GC0148 Send Back was still on-going.

Updates on GC0156 Related Modifications

PaMo talked through the BSC and CUSC modifications which will be raised to update 'Black Start' to 'System Restoration' and other minor amendments (as outlined in the Workgroup meeting slide pack).

A very brief update was provided on the CUSC modifications CMP398 and CMP412 and the STC modification CM089.
