#### Key areas of discussion

The aim of Workgroup 3 was to review the Workgroup Consultation responses and agree on the next steps.

#### Review of Workgroup Consultation Responses

The Chair provided a high-level overview of the two responses received.

The Workgroup agreed to postpone further Workgroup activity until the CATO legislation is approved as currently there was no defect for the modification to resolve.

The Proposer agreed to review their assessments of against the SQSS obligations as there was concern that rather than assessing against enabling CATOs to connect to the system the assessment had been based on the benefits of introducing CATOs.

Workgroup agreed to submit two new Terms of Reference to the SQSS Panel in line with similar requests to the Grid Code Review Panel.

- Consider the cross-code impacts that this modification has, with particular consideration of any consequential impacts to STC, Grid Code, and CUSC.
- Ensure that the proposed SQSS changes effectively implement the CATO regime in a proportionate manner, adopting minimum necessary change whilst also ensuring that the new arrangements are future proofed as much as possible

#### **Proposer Update**

The Proposer talked through their proposal to change 'transmission system areas' with the draft legal text to 'Transmission Area'; and introducing Transmission Area as meaning the same as within the Transmission Licence Standard Licence.

The Workgroup agreed to the changes in principle, but wanted clarity on what was considered to be the CATO's Transmission Area.

#### Review of Terms of Reference and Workgroup Report

The Workgroup did not raise any queries when the Chair shared the updated Terms of Reference.

The Chair provided a high-level update on the draft Workgroup Report in readiness for feedback ahead of Workgroup activity restarting in the summer.

#### **Review of Timeline**

As agreed by the Workgroup the next planned Workgroup meeting is scheduled, following the anticipated approval of the CATO legislation, for 14 August 2023 – with a view of the final report issued to Ofgem in November 2023.

The Chair will share the update Workgroup Report and draft legal text with the Workgroup for review.
