Key areas of discussion

CMP331 seeks to provide new generators with the option to replace the generic Annual Load Factors (ALFs) used to determine their TNUoS charges with a site-specific ALF.

Although the meeting was not quorate, the Workgroup discussed the ESO's analysis re: impact to show how TNUoS charges for existing generators would be impacted by this change, comments on the Workgroup Report and legal text. The discussions from this meeting will be relayed to the missing attendees between now and the final Workgroup meeting on 17 April 2023.

ESO's analysis

- ESO took the 83 generation sites planned to connect (as at 31 October 2022 on the Transmission Entry Capacity register) that would have a generic ALF applied to them.
 ESO then applied their internal "best view" on which of the 83 generation sites would connect and for these replaced the current generic ALF with a % decrease or increase to show the impact on the 2023/2024 TNUoS final tariffs; and
- Locational TNUoS is not impacted and the only impacts are to the Adjustment Tariff (in place to ensure compliance with the Limiting Regulation²), which is smoothed across all generation customers.

Workgroup Report

- Workgroup agreed that a step will be added to the current Operational Notification and Compliance Process (ONCP)³, which is facilitated by the ESO in respect of new generation connections to the National Electricity Transmission System (NETS), for the User to confirm if they are seeking a user provided ALF. This will necessitate a "housekeeping" change to Grid Code if and when CMP331 is approved.
- Workgroup agreed that User provided ALFs (that are agreed) will be published by the ESO but that reports and/or accompanying data provided by the Users will not be published due to commercial confidentiality. However, Workgroup did not fully agree that where User provided ALFs are rejected by the ESO, the ESO will not publically share why rejected. One possible approach is for ESO to instead use existing communication channels, such as TCMF, to share any learnings with the industry.

Legal Text

- Workgroup discussed whether it is more appropriate to change references to "site specific ALF" to "user provided ALF" to avoid confusion on terminology; and
- Workgroup agreed that there will be an obligation on Users to update the ESO if their User provided ALF is no longer accurate.

Next Steps

Final Workgroup Report on 17 April 2023 to discuss any showstopper comments on Workgroup Report and Legal Text, agree that Terms of Reference have been met (initial view at meeting on 27 March 2023 was that they have) and hold Workgroup Vote.

Workgroup Report will then be issued to Panel on 20 April 2023.

Panel on 28 April 2023 will be asked to agree if Workgroup have met their Terms of Reference.
