Key areas of discussion

Review of Action Log

Review of Legal Text

TJ talked the Workgroup through the previously shared legal text and updated documents live on screen with input for the Workgroup. The key topics discussed were:

- OC9: The Workgroup discussed where the obligation around re-synchronising power island should sit as the original wording was deemed to put an obligation on DNOs which they could not achieve. The discussion continued further as to whether the text should be replicated on other areas of the Grid Code to align correctly. The Workgroup concluded that the agreed changes would be added by TJ.
- Appendix 1 – System Restoration: The Workgroup were unsure as to the relevance of the number on the map within in this section, it was agreed that the numbering would be removed.
