Key areas of discussion

Review of Action Log

Outstanding actions were closed.

Review of Legal Text

TJ talked the Workgroup through the previously shared legal text and updated the documents live on screen with input for the Workgroup. The key topics discussed were:

- Distribution Restoration Zone Control System (DRZCS): The Workgroup agreed that as the document should be part of the GC0156 consultation with the caveat that it states that it defines requirement but not dictate how to implement them. The Workgroup discussed the renamed section of Overall Power Island Control and Monitoring (OPICM) to outline the co-ordination of central controllers.
- Data Registration Code (DRC): The Workgroup agreed to remove the “*No information collated under this Schedule will be transferred to the Relevant Transmission Licensees*” statement at the top of Schedule 16 pending ESO legal review.
- Relevant Transmission Licensee obligations: TJ confirmed that obligations will be captured within the STC ESRS modification CM089.
- Offshore Tender Service Provision and Grid Forming: TJ and PM confirmed that Grid Forming was not one of the Tendering service provisions.

Workgroup Vote

- The Workgroup agreed that they had met the Terms of Reference and 13 Workgroup Members voted, with 9 voters saying that the Original Solution was better than the Baseline and 11 that WAGCM1 was better than the Baseline.

Next Steps

The amended Workgroup Report and legal text will be shared by 12 April 2023 ahead of being published as part of the April Grid Code Review Panel Papers on 19 April 2023.
