1 SUMMARY AND RECOMMENDATION

- 1.1 Code Amendments CA001-CA012 propose to amend the STC in order to correct a number of minor errors such as incorrect paragraph numbering, spelling errors, incorrect cross-references and obsolete text.
- 1.2 Amendment Proposals CA001-CA012 were proposed by National Grid and submitted for consideration to the STC Committee Meeting on Tuesday, 19th April 2005. Following their submission SP Transmission Ltd proposed an Alternative Amendment to CA003.
- 1.3 The STC Committee has discussed the Proposed Amendments CA001-CA012 and the Alternative Amendment to CA003 and has recommended that they proceed to the Assessment and Report Phase.

STC Committee Recommendation

- 1.4 The STC Committee recommends that CA001, CA002 and CA004-CA012 be approved for implementation.
- 1.5 The STC Committee recommends that the Alternative Amendment to CA003 be approved for implementation.
- 1.6 Should the Authority approve any of the Amendment Proposals CA001-CA012 and/or the Alternative Amendment to CA003 it is provisionally recommended that the STC be modified 5 business days after the Authority's decision.

2 PURPOSE AND SCOPE OF THE REPORT

- 2.1 This Proposed Amendment Report has been prepared and issued by the STC Committee under the rules and procedures specified in the System Operator Transmission Owner Code (STC) as designated by the Secretary of State. It addresses issues relating to proposed housekeeping amendments to the STC.
- 2.2 Further to the submission of Amendment Proposals CA001-012 (see Annex 1) and the subsequent wider industry consultation that was undertaken by the STC Committee, this document is addressed and furnished to the Gas and Electricity Markets Authority ("the Authority") in order to assist them in their decision whether to implement Amendment Proposals CA001-012.
- 2.3 This document outlines the nature of the changes that are proposed. It incorporates STC Committee's recommendations to the Authority concerning the Amendments.
- 2.4 This Amendment Report has been prepared in accordance with the terms of the STC. An electronic copy can be found on the NGC Industry Information website, at http://www.nationalgrid.com/uk/indinfo/stc

3 THE PROPOSED AMENDMENTS

3.1 The following table is a summary of the Amendment Proposals represented by CA001-012:

4 ALTERNATIVE AMENDMENTS

- 4.1 SP Transmission Ltd has proposed an Alternative Amendment in relation to CA003 in accordance with Paragraph B7.2.2.8 of the STC.
- This Alternative Amendment proposes that upon each update of a section of the STC the whole section should be re-issued as an updated version. This proposal contrasts with the original CA003 that proposed that upon each update only the pages that had changed should be re-issued as an updated version. In support of the Alternative Amendment Proposal SP Transmission cited the greater ease of updating a paper copy of the STC through simply replacing an entire section of the STC rather than the individual pages that had changed. This SP Transmission Ltd stated would therefore better facilitate the Applicable STC Objectives as opposed to the original CA003.

5 EVALUATION PHASE

5.1 The STC Committee has considered the Proposed Amendments CA001-CA012 and the Alternative Amendment to CA003 and believes that no further information is required in order that the Parties may assess the Proposed Amendments. The Evaluation Phase is therefore not required for Amendment Proposals CA001-CA012.

6 STC PARTIES' ASSESSMENTS

This Section contains a summary of the views and representations made by STC Parties during the Assessment Phase in respect of the Proposed Amendments, in accordance with Section B, Paragraph 7.2.5.2 of the STC.

6.2 National Grid Company (NGC) View

6.2.1 NGC is supportive of Amendment Proposals CA001, CA002 and CA004-012 and the Alternative Amendment to CA003. The implementation of the proposed amendments will not have any impact on NGC's Transmission System or IS Systems. No additional works or monies will be required to implement the proposed changes

6.3 Scottish Hydro-Electric Transmission Limited (SHETL) View

6.3.1 SHETL is supportive of Amendment Proposals CA001, CA002 and CA004-012 and the Alternative Amendment to CA003. The implementation of the proposed amendments will not have any impact on SHETL's Transmission System or IS Systems. No additional works or monies will be required to implement the proposed changes

6.4 SP Transmission Limited (SPTL) View

6.4.1 SPTL is supportive of Amendment Proposals CA001, CA002 and CA004-012 and the Alternative Amendment to CA003. The implementation of the proposed amendments will not have any impact on SPTL's Transmission System or IS Systems. No additional works on monies will be required to implement the proposed changes.

7 IMPACT ON THE STC/STCPs

- 7.1 The Proposed Amendments would require amendment to those areas of the STC detailed in the table contained in Paragraph 3.1 above.
- 7.2 The text required to give effect to the Proposed Amendments is contained at Annex 2 of this document.

8 IMPACT ON CORE INDUSTRY DOCUMENTS

8.1 The Proposed Amendments will have no impact on Core Industry Documents or other industry documentation or require any changes to computer systems established under Core Industry Documents.

9 STC COMMITTEE VIEWS & RECOMMENDATION

- 9.1 The STC Committee believes that amendment of the STC on the basis of the housekeeping amendments represented by CA001, CA002, CA004-012 and the Alternative Amendment to CA003 would aid the promotion of good industry practise and efficiency in the implementation and administration of the arrangements described in the STC. The original CA003 would also serve to aid the promotion of good industry practise and efficiency in the implementation and administration of the arrangements described in the STC but it is the view of the STC Committee that it would do so to a lesser extent that the Alternative Amendment to CA003.
- 9.2 The STC Committee therefore recommends that Amendment Proposals CA001, CA002, the Alternative Amendment to CA003 and CA004-012 inclusive should be approved for implementation to retain consistency and improve clarity and hence enable the STC Parties to more efficiently discharge their licence obligations.

10 IMPLEMENTATION AND TIMESCALES

10.1 Should the Authority approve any of the Amendment Proposals CA001-CA012 and/or the Alternative Amendment to CA003 it is recommended that the STC be modified 5 business days after the Authority's decision.

11 COMMENTS ON PROPOSED AMENDMENT REPORT

- 11.1 Views were invited from Industry parties upon the Amendments contained within the Proposed Amendment Report.
- 11.2 The STC Committee received 0 responses following the publication of the Proposed Amendment Report.

Annex 2 – Proposed Text to modify STC

Part A - Text to give effect to the Proposed Amendments

Conformed Version

CA001

Amend Section J, Paragraph 1.1 as follows:

1.1 This Section IJ sets out the general rules to be applied in interpreting this Code . . .

CA002

Amend the following sub-paragraph numbering in Section I, Paragraph 9.1 as follows:

- 9.1.21 Each Transmission Owner shall immediately forward to NGC a complete copy of any application received from a User in respect of a Connection Site (including any application for use of system) during the period commencing on 1 January 2005 and ending on the Go Live Date.
- 9.1.32 NGC may submit an application (a "New Transitional Application"), in accordance with this paragraph 9 and the Agreed Transitional Timetable (referred to in paragraph 10.1), to:
 - 9.1.32.1 the Transmission Owner, if any, whose Transmission System is located at the Connection Site which is the subject of the relevant application or offer (the "Transitional Connection Site");
 - 9.1.32.2 any Transmission Owner in relation to whose Transmission System the Transitional Connection Site satisfies the criteria referred to in paragraph 11; and
 - 9.1.32.3 any Transmission Owner which does not receive a New Transitional Application pursuant to sub-paragraphs 9.1.32.1 or 9.1.32.2 above, but who otherwise receives New Construction Planning Assumptions pursuant to paragraph 9.2 in relation to the Transitional Connection Site.
- 9.1.43 A New Transitional Application submitted pursuant to sub-paragraph 9.1.32 shall contain the information reasonably necessary in order to enable each Transmission Owner to:
 - 9.1.43.1 identify whether construction works would be required in respect of the Connection Site which is the subject of such New Transitional Application; and
 - 9.1.43.1 where relevant, prepare a New Transitional Offer.
